Course Description

Macroeconomics is the study of the aggregate economy. We will explore the determinants of both long term trends and short term fluctuations (business cycles) and explore the roles that consumers, firms, and governments play in the economy. Throughout the semester we will expand on topics discussed in principles of macroeconomics using a more mathematical approach. The topics that will be covered are long run growth, aggregate demand and supply, unemployment and wages, inflation, monetary and fiscal policy, and the recent recession. In addition, we will study the microfoundations of macroeconomic models. In the end you will have the technical tools and knowledge necessary to intelligently read about and discuss current and past macroeconomic events.

Prerequisites

- ECON 1000 or ECON 2020 or equivalent from another institution
- ECON 1078 and 1088, or MATH 1300, or MATH 1310, or MATH 1081, or MATH 1080, 1090 and 1100, or APPM 1350, or equivalent from another institution

This course requires a working knowledge of calculus. There will be no formal review of calculus techniques. Students who do not meet the requirement may be administratively dropped from this course.

Exams

Midterms will not be cumulative beyond the cumulative nature of the material. The final will be cumulative, but focusing more on the new topics covered after the second midterm. All of the exams will take place in the same classroom (HLMS 267). Make sure you do not show up late on the day of the exam. In any case, no extra time will be given. Please bring a basic calculator. Smartphones and graphing calculators are not permitted.

Note that **I** will not give early/late exams or make-up exams. If you miss either of the midterms, the final exam will be re-weighted. If you have three or more final exams on the same day, you can reschedule the final for a different time or day. To qualify for this, you must provide me your final exam schedule ASAP, but no later than the late drop deadline (11/2).
