Textbooks (NOT Required): *International Economics* (9th edition) by Steven Husted and Michael Melvin.

Course Description and Objectives: This course covers economic concepts relating to the international economy and important developments in the global economy. The economic theory emphasized in the class will give the student a better understanding of the foundations for international trade. Understanding this material will allow students to relate the importance of trade to political and cultural relations. In this course we undertake an in-depth study of the theories, policies, and institutions of international trade and finance. We have three basic objectives.

- The first is to build an analytical framework within which we can develop a logical approach to investigating international economics. The idea is for us to “think like economists,” an approach that gives students both a sound basis for understanding the complexities of international commerce and the objectivity needed for assessing various policy proposals. An emphasis will be made on the assumptions underlying common trade models, and you will be expected to think critically about these assumptions and the models over all.
- The second goal is to gain a fuller appreciation of the complicated economic interrelationships that link nations and peoples. For example, why might the economies of the European Union and Japan continue to stagnate? These are complex issues without easy answers, but the goal is to establish a coherent, consistent, and realistic framework for thinking about them.
- The final objective is to apply the economics of trade to the world surrounding us. For example, it is not enough just to know how trade barriers work. We should investigate also why such policies exist and how costly or beneficial they are.

COURSE POLICIES:

General:

- Class periods will be devoted to lecture, practice, and the occasional (time permitting) in class activity. Participation is important and will be a decent part of your grade. Participation will be based %50 attendance and %50 on in class participation- i.e. answering questions, contributing to practice, participating in activities, ect.

- **Four** absences will be dropped at the end of the semester. This is meant to cover **excused** absences. If you have more than four excused absences, please bring me the documentation for *each* of the absences you would like excused at the end of the semester. For example, if you have five excused absences and would like *all* five dropped, you must bring me documentation that covers all five.
- If you do not feel comfortable participating in class these points can be made up by attending office hours, **attendance cannot** be made up in this manner.

Problem Sets:

- There will be a problem set due every two or three weeks. Due dates are listed in the tentative schedule below. The problems will mirror the types of questions that will be on the exams. No late assignments will be accepted.
- Problem sets can be completed in groups of **up to 4**, but larger groups may be graded more harshly. Groups should only turn in one copy.

Exams:

- **Midterms:** Two midterms will be given during lecture time on the dates in the schedule given in this syllabus. For students with documented accommodations for exams, please notify me with your documentation at least one week before the first exam.
 - **Note:** Makeup exams are not given. If the student misses a midterm due to emergency, the weight of the midterm will be placed on the final exam (meaning the final exam will be worth 50% of their grade).
- **Final Exam:** The final exam is cumulative. The exam will be held at the university assigned place and time. This date is non-negotiable. The only exception to this standard is if you have 3 final exams scheduled on the same day; in this circumstance, you must notify me before the 11th week of the semester.
