***Course Objectives:***

The primary objective of this seminar is to provide a framework which will lead to the successful completion of your honors thesis for those of you planning to graduate in May 2007 and to help successfully launch the thesis project for those of you planning to graduate in December 2007. This course allows you to do your own economic analysis on a topic that interests you. My hope is that you will learn that the doing of, as well as the learning of, economics can be both satisfying and fun. You will be required to submit written material to me on a regular basis. Also you will each present this work to the class. The group will be responsible for providing constructive feedback.

While much of the course revolves around formal presentations, we need to strive to maintain a workshop atmosphere. There is enormous collective knowledge within our workshop group. In order to facilitate the exchange of ideas and suggestions, ample discussion time is built into the schedule. Attendance is mandatory for all scheduled classes.

***Evaluation***

Students graduating and completing their honors theses this semester will receive a grade based on their honors thesis, oral defense, and class participation. Students who do not graduate this semester will receive a grade based on their thesis proposal and class participation. The proposal should include a literature review, a statement of thesis objectives, data sources and a discussion of how the thesis relates to the literature. Economics 4339 does not count towards economics major credit hours, but only as elective hours towards the total Arts and Sciences hours required for graduation. However, it does provide you with a framework within which you can work on your honors thesis and the support of your peers as you go through the process.
