#### **COURSE OVERVIEW**

This course introduces a theoretical framework to model the behavior of individual decision makers. The course is divided into three parts: preferences and consumer behavior; decision making by firms; and interaction of firms and consumers in markets. We will consider three market structures: perfect competition, monopoly and oligopoly.

The techniques covered in this course will be useful for anyone intending to pursue field courses in economics such as industrial organization, international trade, labor and environmental economics.

#### **PREREQUISITES**

- 1. Economics prerequisites: ECON 1000 or 2010
- 2. Mathematics prerequisites: ECON 1078 & ECON 1088 or MATH 1300 or MATH 1310 or MATH 1081 or MATH 1080 & 1090 & 1100 or APPM 1350 or equivalent.

The material covered in this course requires basic calculus. It will be assumed that every student has a working knowledge of calculus. The mathematics prerequisites will be strictly enforced.

#### LECTURES

Attendance will be taken daily. Practice problem sets will be periodically posted on the course website. These will NOT be graded and are for your practice only.

#### **EXAMS**

Each exam will have two sections: a multiple-choice section and a short answer section. Please bring a #2 pencil and a non-graphing/non-scientific/non-financial calculator to the exam (a ruler is also recommended). If you bring a graphing calculator or cell phone calculator to the exam, 5 points will be deducted from your grade on that exam.

Midterm exams will not be cumulative. Exam material will be based on the lecture notes, articles and practice problem sets. I will announce before each exam the topics that will be included.

Midterm 1 will take place on **Thursday, February 17**<sup>th</sup> and midterm 2 will take place on **Thursday, April 7**<sup>th</sup>. Midterm exams will be held in the usual classroom during lecture time. **The final exam will be cumulative** and will take place on **Wednesday, May 4**<sup>th</sup> from **4:30 p.m. to 7:00 p.m.** It will be held in the usual classroom.

There will be no extra credit opportunities.

<u>Note:</u> If you have 3 or more final exams on the same day, you are entitled to arrange an alternative exam time for the **last** exam scheduled on that day. To qualify for rescheduling final exam times, you must provide evidence that you have 3 or more exams on the same day, and you must make arrangements **no later than Friday, February 18<sup>th</sup>, 2011**.

#### **ARTICLE ANALYSIS**

Article analysis constitutes 10% of your course grade. There will be 3 articles out of which the best 2 will count towards your grade. The schedule of when articles are due is given below.
