Course Overview

This course provides a comprehensive framework for analyzing the behavior of aggregate economies. The determination of income, employment and prices, as well as discussion of economic growth, business fluctuations and macroeconomic policies is included. The primary objective of this course is to demonstrate how the economy actually works.

This course is divided into three parts. The first part deals with long-run theories of economic growth. We will study the simple production model, the Solow and the Romer growth models. Topics related to determination of unemployment and inflation in the long run will be covered as well. The second part deals with short run economic fluctuations. Theories like IS-MP and AD/AS will be discussed in the closed economy and open economy frameworks. The third part of the course will be concerned with macroeconomic policies and government, international trade and finance issues.

Prerequisites

Economics prerequisites: ECON 1000 or 2020.

Mathematics prerequisites: ECON 1078 and 1088, or MATH 1300, or MATH 1310, or MATH 1081, or MATH 1080, 1090, and 1100, or APPM 1350, or equivalent. Consult with your adviser if you have questions regarding prerequisites.

Course Structure

This course will consist of lectures, readings, assignments and exams. The material covered during lectures will be necessary to succeed in the course, thus **lecture attendance is mandatory!**

I do not give out or post my notes. Any material covered during lectures, in homework and readings is a potential candidate to be in an exam.
