

## EXTERNAL FELLOWSHIPS AND SCHOLARSHIPS

### *AAUW International Fellowships*

International Fellowships are awarded for full-time study or research in the United States to women who are not U.S. citizens or permanent residents. Both graduate and postgraduate studies at accredited U.S. institutions are supported.

Originally designed to provide Latin American women opportunities for graduate and postgraduate study in the United States, the International Fellowships program awarded its first fellowship in 1917. The program now includes women from around the world, and International Fellowships have been awarded to more than 3,400 women from more than 140 nations.

### *AAUW American Fellowships*

Support women doctoral candidates completing dissertations or scholars seeking funds for postdoctoral research leave from accredited institutions. Applicants must be U.S. citizens or permanent residents.

Candidates are evaluated on the basis of scholarly excellence, teaching experience, and active commitment to helping women and girls through service in their communities, professions, or fields of research.

The AvH awards 10 German Chancellor Scholarships annually to prospective leaders from the U.S.A., Russia and China in the academic, economic and political fields, enabling them to carry out research projects of their own choice in Germany;

During one-year research stays, scholars are also given an opportunity to gain an insight into the social, cultural, economic and political situation in Germany;

### *Andrew W. Mellon Foundation/ACLS Early Career Fellowships*

ACLS invites applications for the second annual competition for the Mellon/ACLS Dissertation Completion Fellowships. These fellowships are to assist graduate students in the humanities and related social sciences in the last year of PhD dissertation writing. This program aims to encourage timely completion of the PhD.

Applicants must be prepared to complete their dissertations within the period of their fellowship tenure or shortly thereafter. ACLS will award 65 Fellowships in this competition for a one-year term beginning between June and September. The Fellowship tenure may be carried out in residence at the Fellow's home institution, abroad, or at another appropriate site for the research. The total award of up to \$38,000 includes a

stipend plus additional funds for university fees and research support. These Fellowships may not be held concurrently with any other major fellowship or grant.

### ***AERA Dissertation Grants***

AERA invites education-related dissertation proposals using NCES, NSF, and other national databases. Dissertation Grants are available for advanced doctoral students and are intended to support the student while writing the doctoral dissertation. Applicants for Dissertation Grants may be U.S. citizens, U.S. permanent residents, or non-U.S. citizens. Awards for Dissertation Grants are up to \$20,000 for 1-year projects. In accordance with AERA's agreement with the funding agencies, institutions may not charge indirect costs on these awards. Successful grantees may consult with NCES or NSF staff regarding their proposed research projects and the handling of NCES, NSF, and other federal agency data sets pertinent to their projects. Dissertation grantees' final reports may either be an article of a quality and in a format suitable for publication in a scholarly journal, or a copy of the dissertation.

### ***AERA Minority Dissertation Fellowship Program***

The American Educational Research Association (AERA) is pleased to announce the AERA Minority Dissertation Fellowship in Education Research. The Council of the AERA established the fellowship program to provide support for doctoral dissertation research, to advance education research by outstanding minority graduate students, and to improve the quality and diversity of university faculties. This fellowship is targeted for members of racial and ethnic groups historically underrepresented in higher education (e.g., African Americans, Alaskan Natives, American Indians, Asian Americans, Hispanics or Latinos, and Native Hawaiian or Pacific Islanders). This program offers doctoral fellowships to enhance the competitiveness of outstanding minority scholars for academic appointments at major research universities. It supports fellows conducting education research and provides mentoring and guidance toward the completion of their doctoral studies.

### ***AERA Research Grants.***

With support from the National Science Foundation (NSF), the AERA Grants Program announces its Research Grants competition. The program seeks to stimulate research on U.S. education issues using data from the large-scale, national and international data sets supported by the National Center for Education Statistics (NCES), NSF, and other federal agencies, and to increase the number of education researchers using these data sets. The program supports research projects that are quantitative in nature, include the analysis of existing data from NCES, NSF or other federal agencies, and have U.S. education policy relevance.

### *AIR/NCES Fellowship for Graduate Study*

This research and dissertation fellows program is a partnership between the Access Group Center for Research & Policy Analysis<sup>SM</sup> and the Association for Institutional Research (AIR). The program is a grant competition promoting scholarship on issues related to access, affordability and value of legal education specifically, and graduate and professional education more broadly. Preference is given to proposals that utilize regional, national, or multi-institutional datasets, although research that focuses on a single institution is acceptable. Preference is also given to proposals that specifically address legal education; however, proposals that study access, affordability and value of graduate and professional education more generally are also encouraged. Researchers may analyze pre-existing data or include the construction of a new dataset in their proposal. Membership to Access Group or AIR is not required for grant eligibility.

The American Indian Graduate Center (AIGC), a non-profit organization, was established in 1969. Founders Robert L. Bennett (Wisconsin Oneida) and John C. Rainer (Taos Pueblo) created a program to assist American Indian college graduates to continue their education at the masters, doctorate and professional degree level. AIGC was founded to help open doors to graduate education for American Indians and to help tribes obtain the educated Indian professionals they need to become more self-sufficient and to exercise their rights to self-determination.

### *Arnold L. Mitchem Dissertation Fellowships*

In 2002, Marquette established the Arnold L. Mitchem Dissertation Fellowship Program, intended to increase the presence of underrepresented ethnic groups by supporting doctoral candidates in completing their final academic requirement, the dissertation.

The fellowship provides a student from other U.S. universities with one year of financial support, including a stipend, fringe benefits, and research and travel funds. The fellow will be in residence at Marquette for an academic year, during which the recipient will teach one course in his or her area of specialization while completing his or her dissertation. The recipient will also participate in a formal mentoring program.

Applicants must be U.S. citizens who are well under way in their dissertation writing and who belong to a racial or cultural group historically underrepresented in the U.S. professoriate. African-American, Native-American and Hispanic-American candidates are especially encouraged to apply.

Applicants should have completed all other requirements for their Ph.D. degree, and must be in the last stage of their doctoral program;

The Congressional Black Caucus Foundation's Congressional Fellows Program was initiated in 1976 as the Graduate Intern Program. It was motivated by concern that Black professionals were seriously under-represented on Capitol Hill. In 1982, the CBCF expanded the internships into more in-depth nine-month Fellowships to allow for greater research and public policy analysis opportunities. Since its inception, more than 150 individuals have served as Fellows and many have gone on to full-time positions on Capitol Hill and in prominent public policy organizations.

### *Izaak Walton Killam Postdoctoral Fellowships (KPDF)*

The Killam Scholarship and Prize Programmes were established in memory of Izaak Walton Killam through the Will of his wife, Dorothy Johnston Killam, and through gifts made during her lifetime. Their primary purpose is to support advanced education and research at five Canadian universities and the Canada Council for the Arts. The UBC Killam Postdoctoral Research Fellowships are provided annually from the Izaak Walton Killam Memorial Fund for Advanced Studies and are available for most fields of research. It was Mrs. Killam's desire that those selected to receive fellowships: "be likely to contribute to the advancement of learning or to win distinction in a profession. A Killam scholar should not be a one-sided person... Special distinction of intellect should be founded upon sound character." The number of new awards offered each year presently varies between three and five.

### *National Science Foundation – Political Science Program*

The Political Science Program supports scientific research that advances knowledge and understanding of citizenship, government, and politics. Research proposals are expected to be theoretically motivated, conceptually precise, methodologically rigorous, and empirically oriented. Substantive areas include, but are not limited to, American government and politics, comparative government and politics, international relations, political behavior, political economy, and political institutions. In recent years, program awards have supported research projects on bargaining processes; campaigns and elections, electoral choice, and electoral systems; citizen support in emerging and established democracies; democratization, political change, and regime transitions; domestic and international conflict; international political economy; party activism; political psychology and political tolerance. The Program also has supported research experiences for undergraduate students and infrastructural activities, including methodological innovations, in the discipline.

Test of English as a Foreign Language (TOEFL) Small Grants for Doctoral Research in Second or Foreign Language Assessment support up to ten students each year with grants with a value of up to \$2,000 each. Eligible graduate students are those registered in a doctoral program within or outside the U.S. leading to a degree with a specialization in second or foreign language assessment. Students must have completed all course and examination requirements, and the dissertation proposal must have been approved. Applicants must clearly identify how the TOEFL grant would assist in dissertation completion.

***Williams College Gaius Charles Bolin Dissertation Fellowships***

The Gaius Charles Bolin Fellowships at Williams College are designed to promote diversity on college faculties by encouraging students from underrepresented groups to complete a terminal graduate degree and to pursue careers in college teaching. The Bolin Fellowships are two-year residencies at Williams, and two scholars or artists are appointed each year. Fellows devote the bulk of the first year to the completion of dissertation work—or in the case of MFA applicants, building their professional portfolios—while also teaching one course as a faculty member in one of the College's academic departments or programs. The second year of residency (ideally with degree in hand) is spent on academic career development while again teaching just one course.

The Woodrow Wilson Dissertation Fellowship in Women's Studies encourages original and significant research about women that crosses disciplinary, regional, or cultural boundaries. Previous Fellows have explored such topics as transnational religious education for Muslim women, the complex gender dynamics of transidentity management, women's electoral success across racial and institutional contexts, women's sports, militarism and the education of American women, and the relationship between family commitments and women's work mobility.
