COURSES TAUGHT

Black Feminism, Womanism and Social Transformation. This course introduces students to the lived experiences of Black women in the struggle to make sense of their lives in Africa and Diaspora.

Intersectionality and Black Queer Experience. This course introduces the students to the concept of intersectionality through African(a) queer experience in the nineteenth and twentieth centuries.

Introduction to African Politics. This course is designed to look at contemporary African politics from the perspective of State and non-state actors to discuss ideas and practices of citizenship.

Introduction to Methods (Game Theory). This course introduces the core concepts of game theory and how it helps understand political and social phenomena. It emphasizes decision-making, model building skills and problem solving through quantitative and qualitative reasoning.

Introduction to Public Policy. This course uses both theory and practical examples to provide a better understanding of public policy analysis at the local, national and international levels.

Strategic Choice. This is a freshmen seminar that introduces students to the idea of strategic choice and thinking. Some of the questions we explore are "what is strategy? What does it mean to choose? How do people go about influencing circumstances with no or little choice? In addition to case studies, students deal with the theories and concepts that help us understand choice and strategy for individuals and organizations.

Public Procurement and Global Governance. Master Class offered to public administrators and scholars of public administration in the Republic of Zambia.

Senior Research Seminar. This capstone seminar provides students with the opportunity to conduct guided research and share their findings through writing and public presentations.

Introduction to Global Politics/International Relations. This course surveys current themes in global politics. It introduces students to key concepts, theories and patterns for understanding politics in the international arena. It aims to expose students to a broad spectrum of ideas in international relations and comparative politics and does so by examining some enduring questions in the study of politics.

International Development and Social Change. The course begins with theories and explanations of how nations have historically attempted to modernize themselves and develop their economies. It concludes with a brief introduction to current debates on economic globalization.

Introduction to American Politics. This is an introductory course to American politics and government. It specifically focuses on democracy, its origin, evolution, institutions and challenges in a changing world.

The Business of War. This course introduces students to the history and origin of war contracting in the United States from the Revolutionary War until World War I.

Identity Negotiation. The course is concerned with sexual/gender identity negotiation in non-

Western settings.

International Relations of China part II. The course introduces students to the political history of China from Deng Xiaoping until the early 1990s.

International Relations of China part I. The course introduces students to the political history of China from the Cultural Revolution to early reform under Den Xiaoping.

World Politics. The course introduces students to world affairs and current debates.
