Benefit	Notes
Inpatient surgery (in-network)	\$200 copayment per admission, plus 20% coinsurance after \$500 deductible is met
Outpatient services (in-network)	20% coinsurance after \$500 deductible is met
Outpatient behavioral health (in-network)	\$0 copayment
Inpatient surgery (out-of-network)	\$200 copayment per admission, plus 50% coinsurance after \$1,000 deductible is met
Outpatient services (out-of-network)	50% coinsurance after \$1,000 deductible is met
Outpatient behavioral health (out-of-network)	50% coinsurance after \$1,000 deductible is met

What is not covered by University of Colorado Boulder?

Some services are considered cosmetic and not covered by University of Colorado Boulder. You may still receive these services, but they would not be covered by your insurance.

- Liposuction
- Facial bone reconstruction
- Voice modification surgery
