## **Course Overview**

This course is an introductory international affairs course and has multiple goals. IAFS courses at CU-Boulder explore global issues within political, cultural, economic, social, and military frameworks. Students of international affairs are interested in the connections between nations, societies, technologies, and ideas. The course is designed to introduce you not only to key topics, crises, and countries of interest to the international community but also to many of the best-known organizations, media outlets, and authors within that community.

Since IAFS majors are expected to think critically and write intelligently about a wide variety of topics, this course also allows you to hone your skills as scholars. We will deepen our reading, reasoning, and writing skills through discussion and writing assignments.

Although this is an entry-level course and assumes no prior knowledge, it is not an easy course. Since this is a is four-credit course, it requires a substantial amount of reading and writing throughout the semester.

You will be expected to read a variety of articles, books and book excerpts, and other documents in a timely manner. It will require you to think critically about what you read and to apply what you have learned on a daily basis. We expect everyone to have done the reading—your consistent effort and participation is key to the course's overall success. If you do not think you are up to the task of actively engaging yourself in the learning process, please drop the course now.

# **Course Objectives**

The objectives of this course are to:

- Introduce you to key problems of interest to the global community and how various international actors understand, interpret, discuss, and attempt to resolve those problems
- Introduce you to sources commonly used by those working in the realm of international affairs
- Encourage your interest in current events, especially as they are related to geopolitics
- Improve your reading comprehension, critical thinking, and synthesizing skills
- Further develop your writing skills

### **Course Structure and Expectations**

I will lecture and provide short opportunities for discussion and/or Q & A each Tuesday and Thursday session from 12:30 to 1:45 pm Mountain Time. (Lecture will occur on Zoom during the first two weeks and shift to Hale 270 on 1/25 if all goes according to plan.) Attendance will not be taken, but it is crucial for your overall success to attend consistently and listen actively. Your Teaching Assistants will also make note of who participates in discussions during the class lecture. Complete the reading listed under each class day <u>before</u> our class starts. Additionally, the information presented will be useful for each recitation section.

Your recitation will cover supplemental readings connected to the issues presented in lecture for the week. These readings, which will be the same across recitation sections, are found in a module for the week on our primary Canvas page. Attendance is required in recitation and will be factored into your recitation grade (20% of your overall course grade). You must attend the recitation section in which you are enrolled.

For Week Two's remote recitation, you are also required to have your video on during recitation unless you provide your TA with a reasonable explanation <u>in advance</u> of the class session. It is your responsibility to make sure your camera and microphone are working prior to the start of class time. Please be sure to find a suitable, quiet spot for your participation in recitation. Participation in recitations will be factored into your recitation grade as well.

### Communication

Please expect that it may take up to 24 hours during the week for me or your TA to respond to email. We hope to respond quickly but make sure you do not assume that because we are working remotely you can wait to the last minute to ask questions. Expect emails sent on the weekend to receive replies on Monday.

I am also happy to set up one-on-one zooms if you would like help discussing paper or exam prep, etc. Email me and we can find a mutually agreeable time. Short, straightforward queries are still best handled via email exchange or immediately after class.

# Papers 1 -

You will be required to complete two **five-to-seven page papers**. More details and specific paper prompts will be provided about two weeks prior to their due date. The first, **due on Friday, February 18**, will ask you to make an argument about ongoing debates surrounding globalization, while the second, **due Friday, April 8**, will ask you to examine Trevor Noah's memoir, *Born a Crime*, as a source for understanding apartheid in South Africa and the issue of race in international affairs more broadly.

## Exams

You will also have a **Midterm on Thursday**, **March 10** and a **Final Exam on Saturday**, **April 30**. The format for both will be a mix of multiple choice, short answer questions, and essay responses. The final exam will deal with material assigned after the midterm, but will still require you to understand the earlier major concepts we have learned. More information on exam logistics to follow.

### **Syllabus Statements**

#### **Classroom Behavior**
