Understanding the links between parental and adolescent substance use: complementary natural experiments using the children of twins design

Rigorous evaluation of how parents shape their children's behavior has major implications for our understanding of family functioning and motivates policies or interventions promoting specific parenting practices. We propose examining the intergenerational impact of marijuana use and disorder using two complementary natural experiments in 6,457 individuals from 1,902 families in Colorado and Minnesota. We will use the children of twins design to test the extent of direct environmental impact of parents while controlling for genetic confounds, and conduct a state-by-state comparison of parental and adolescent marijuana use and disorder, parenting practices, and family environment, leveraging the marked differences in marijuana laws and substance use norms in Colorado and Minnesota.
