Submission Criteria and Guidelines

Nominations that do not fall within the criteria below will not be considered for an award.

- Nominations should be a minimum of 200 words and may not exceed 500 words.
- Nominations should be submitted for actions and activity occurring from 7/1/2023 - 6/30/2024, although some awards may allow for a wider range of consideration.
 - Nominations submitted for actions and activity occurring **after** the Involvement Awards ceremony may require additional information.
- Submissions that are word for word duplicate or strikingly similar, will be reviewed as one submission.
- Scores will NOT be based on number of submissions but quality of nominations.
- After initial reviews, nominations that do not meet qualification standards for an award will be notified with an opportunity to change the award category.
- Only one winner will be selected for each award category, as such nominations should **not** contain multiple nominees. If you are looking to nominate more than one individual or group, please do so by submitting separate nominations.

Awarding Criteria and Guidelines

The Involvement Awards review Committee will be made up of student leaders, student staff, university partners, and CSI staff. Individuals on this committee represent different areas of campus and are asked to uphold the guidelines below.

- Grammatical and spelling errors will not count against nominees and reviewers will do their best to grasp the concept of the whole nomination. However, if such errors make the nomination incomprehensible, the reviewer may score accordingly.
- Reviewers will NOT base scores on the **number** of submissions for one nominee but the **quality** of nomination.
- Reviewers will be provided with rubrics to facilitate their grading. Winning nominations will be those with the highest score in their award categories.
- *All award nominations* will have a General Award Rubric evaluating whether the nomination met the criteria and whether the nominee exhibited Impact & Exemplary Nature.
- Additionally, each **award category** will have a specific focus they will be evaluated on.

Definitions

Student Group - any student-led program or club on campus.

Recognized Student Organization (RSO) - any student organization that is officially registered with the Center for Student Involvement.

Recognized Social Greek Organization (RSGO) - any Greek organization that is officially registered with the Center for Student Involvement and the Fraternity and Sorority Life office.

University Sponsored Program - any student-led board or entity that functions as an official part of a University Department. Examples include but are not limited to: CU GOLD, CU NightRide, Distinguished Speakers Board, Residence Hall Association.

University Department - any officially funded and recognized department, office, or cost center on CU Boulder's campus.

Student - any fully enrolled, fee-paying student at CU Boulder.

Staff - non-teaching university employee

Faculty - academic/instructor/professor employee

Student Group Awards

Social Action Award:

This award recognizes a **student group** that possesses awareness of current issues and has demonstrated activism to create a positive impact within their community. With a clear voice, this organization has acknowledged the power students can have in effecting change.

They create lasting impact on campus through their activities including but not limited to leadership development, community engagement, mission-driven planning and have a direct influence on the quality of life for students on campus. Please note Recognized Student Organizations (RSOs) and Recognized Social Greek Organizations (RSGOs) are not eligible for this award.

Examples of ways in which this student models leadership may include activism, community service, on-campus involvement, or showing initiative in creating or spearheading efforts to make the campus a welcoming place for all graduate students.
