PROBATION/SUSPENSION: WHAT IT MEANS

Students who are not doing well academically and have less than a passing grade point average (GPA) will be put on academic probation. This is a warning you are not doing well enough to graduate with a degree. You will be expected to raise your GPA to a passing level in order to continue your studies at CU.

If you are unable to obtain a passing GPA in the time required by your college, you will be academically suspended. Suspension means you may no longer enroll in Boulder main campus courses, although you may be able to take classes through CU's Division of Continuing Education.

OPTIONS AVAILABLE IF YOU ARE SUSPENDED FROM CU

There are immigration ramifications if you are suspended from CU and you are an F1 international student. If you are suspended from CU, your options are the following:

1. TRANSFER TO ANOTHER SCHOOL

If you are admitted to another school within 21 days of the notice of suspension, ISSS will be able to transfer your SEVIS record to the new school. This option allows you to continue your studies in the U.S. and maintain your F1 status. However, 21 days is a very short amount of time to obtain admission to another school. If you are a sponsored student, you must make sure your sponsor approves of the transfer to the new school before you transfer.

2. TAKE A FULL COURSE OF STUDY IN CU'S DIVISION OF CONTINUING EDUCATION

If you are able to maintain full-time enrollment through CU's Division of Continuing Education, then ISSS will maintain your SEVIS record. However, it can be difficult to find a full course of study through Continuing Education, since most of their classes are only offered at night. You must also keep in mind that only 3 credits of distance education (online) courses will count toward full-time enrollment. Also, if you are a sponsored student, it is possible your sponsor will not pay for Continuing Education courses. You must receive prior approval from your sponsor before you register for classes at Continuing Education.

3. CONCURRENTLY ENROLL AT CU AND ANOTHER SCHOOL.

It is possible for you to concurrently enroll at both CU and another school (Front Range Community College, Naropa University, etc.). If the total amount of credit hours at both CU and the other school makes you full time, ISSS will be able to maintain your SEVIS record. You will need to complete a Concurrent Enrollment form from ISSS, show evidence of registration at the other school, and provide transcripts at the end of the semester, showing you completed the courses at the other school. You must have at least one on-campus course at CU's Division of Continuing Education for this to work.

4. LEAVE THE U.S.

If you decide you no longer wish to pursue your studies in the United States, you must inform ISSS as soon as possible and ISSS will terminate your SEVIS record for authorized early withdrawal. After your F1 status has been terminated for authorized early withdrawal, you have a 15-day grace period in which to exit the U.S. or apply for a change of status, if eligible.
