Classes noted with an asterisk (*) indicate that it is not part of bidding. There will be a special signup via the listserv for more details. Students who miss the signup deadline must wait to enroll starting in mid-April after bidding ends.

Clinic Information***CLINICS ARE NOT PART OF THE 14-CREDIT CAP.***

All clinics are not part of course bidding and have a special registration form administered through the Clinic Office in March 2025. If the clinic is year-long, students receive credits for both fall and spring terms. For example, if it is noted here as four credits for fall term and four credits for spring term, students receive eight total credits for the year. If it is noted here as three credits for fall term and three credits for spring term, students receive six total credits for the year.

Other Fall Course Notes

1. 2L and 3L students can take up to 18 CR a semester.
2. Fallsession courses are part of fall tuition and fall term. Students can take one fallsession course. Those who choose to do that can take up to 19 or 20 total CR since fallsession courses are done prior to the beginning of the term.
3. Students cannot take classes which overlap in times and/or have the same start/end times.
4. M=Monday, T=Tuesday, W=Wednesday, Th=Thursday, F=Friday
