Most students do not come to the law school to take remote exams. Example: For a three-hour exam, students should begin **NO LATER** than 10am on exam day.

Take Home Exams: Must be taken on the scheduled exam date and are available from 8am to 5pm. These are 9 hour exams. Responses must be submitted no later than 5pm. They may be taken at home or at the law school.

In-Person Exams: Students must report to assigned classrooms in Wolf Law Building, likely different than the regular classroom space. It is recommended that students arrive at least 15 minutes early to check in with proctors.

General Information

1. Each exam must be taken on the designated date and time for each exam (unless the Registrar contacts you about a required rescheduled exam).
2. Students must keep track of the time that elapses from when you start your exam, and not exceed the time limit noted for that exam. Not stopping your exam when the allowed time has passed is treated as an honor code violation.

Remote-Timed Exams: Must be taken on the scheduled exam date and are available from **8am to 1pm**. Responses must be submitted no later than 1pm. They may be taken at home or at the law school. Most students do not come to the law school to take remote exams. Example: For a three-hour exam, students should begin **NO LATER** than 10am on exam day.

Take Home Exams: Must be taken on the scheduled exam date and are available from 8am to 5pm. These are 9 hour exams. Responses must be submitted no later than 5pm. They may be taken at home or at the law school.

In-Person Exams: Students must report to assigned classrooms in Wolf Law Building, likely different than the regular classroom space. It is recommended that students arrive at least 15 minutes early to check in with proctors.

Untimed Exams: Students take these exams on their own time over more than one day during the exam period. Exams are usually administered via Canvas and students must pay attention to the exam availability and due date.

General Information

1. Each exam must be taken on the designated date and time for each exam (unless the Registrar contacts you about a required rescheduled exam).
2. Students must keep track of the time that elapses from when you start your exam, and not exceed the time limit noted for that exam. Not stopping your exam when the allowed time has passed is treated as an honor code violation.
3. Students are expected to take exams in the designated exam spaces at the noted times and dates. There is usually one room each day for students to take rescheduled exams as directed by the Registrar's Office.
4. Rescheduled exams must be taken in the same exam modality as originally scheduled (in person, remote-timed, take home, etc). Exams cannot be taken earlier than their scheduled exam date.

Rescheduled Exams:

Students with rescheduled, in-person exams should report to the room noted on your individual exam schedule in the exam portal. Make sure to move about the building quietly. Students will be taking different exams. Students should not communicate with their professors about rescheduled exams.

Students taking rescheduled remote-timed or take home exams do not have to come to the law school to complete their exams and they will be available to take in Exam4 during the regularly scheduled times (remote-timed 8am to 1pm and take home 8am to 5pm).
