Per law school rules, exam reschedules must go through the Law Registrar at [lawreg@colorado.edu](mailto:lawreg@colorado.edu). Timed remote exams are not considered to be "take home" exams as defined by the law school rules. Only the Bioethics and Family Law are considered "take home" exams this term. As a result, students should only need a rescheduled exam if they have one of the following:

1) More than three exams in a week, 2) two exam scheduled on the same day, or 3) Family Law and Bioethics (which does not apply to anyone this term). Additionally, there are also provisions in the law school rules to ask for a rescheduled exam for extenuating circumstances. Refer to the law school rules for more information.
