Note: All clinics are not part of bidding and had a special registration form administered through the Clinic Office **last spring**. It is too late to add a clinic for spring 2022 if you did not sign up through the clinic registration process last spring. If the clinic is year-long, students receive credits for both fall and spring terms. For example, if it is noted here as four credits for fall term and four credits for spring term, students receive eight total credits for the year. If it is noted here as three credits for fall term and three credits for spring term, students receive six credits for the year.
