## Transfer and Visitor Application Instructions

1. Completed application. Please send your completed application, along with a check or money order for \$65, made out to the *University of Colorado*, for our non-refundable application fee, to the following address:

- 2. Required personal essay. The essay should be no longer than 500 words, typed, and double-spaced. Please submit an essay, in your own words, on the topic above.
- 3. Your resume or CV. Please show volunteer activities as well as paid work experience.
- 4. Two letters of recommendation. At least one of the letters should be from a law school professor. A copy of the Evaluation of Applicant form must accompany the letters. This form is available on our website (http://lawweb.colorado.edu/apps/catalog).
- 5. Transcripts. Submit transcripts for all previous college, university, and law school work. Please also submit a letter of good standing from the dean of your current law school. If you are applying to visit, please also include a letter granting permission from your home school for you to visit at Colorado Law. Transfer applicants should include their class rank information.
  - If you are selected for this program, you will be required to submit two original transcripts from each college and/or university and law school attended.
- 6. CAS report. Submit a copy of the first page of your CAS report. Your law school should be able to provide you with a copy.
- 7. If you believe you qualify for in-state tuition status in Colorado, also complete the In-state Tuition Classification Application form, which is available on our website at www.colorado.edu/law/admissions/application-and-catalog.

### **Additional Information:**
