<u>Buff Portal</u> will have your complete fall term 1L schedule. Students are in one of six Legal Writing sections during their 1L year. They are labeled LAWS 5226-801, 802, 803, etc. Your Legal Writing section (the 8XX number) indicates which section you are a part of for fall term. Your 8XX number attached to your Legal Writing section and where your last name falls in the alphabet will dictate what days of the week you will attend class in-person versus remotely. Students will fall into one of two groups:

- One group will attend class Mondays and Tuesdays in person and then will be remote on Wednesdays and Thursdays. The other group will attend class remotely on Mondays and Tuesdays and then will attend class in person on Wednesdays and Thursdays.
- Groups will rotate attendance on Fridays (as indicated on the schedule).

All courses will occur in the Wittemyer Courtroom. Legal Writing courses will occur in the Garden Level Conference Room.

NEW AS OF 8/14/2020: Professors Benhalim (Contracts), Schlag (Torts) and Bruce (Legal Writing) will teach remotely. Professor Chen (Leg Reg) will teach remotely, but she may be present for some in-class meetings. On their designated in-person days, students should go to the classroom for class if enrolled in these sections. The professor will teach using the classroom technology in the room. Professors Surden and Schlag switched sections of Torts (changes are reflected below- Schlag will teach LAWS 5425-801 and Surden will teach LAWS 5425-802).
