Note: All clinics had a special registration form administered through the Clinic Office. If the clinic is year-long, students receive credits for both fall and spring terms. For example, if it is noted here as four credits for fall term **and** four credits for spring term, students receive eight total credits for the year.

2L and 3L students can take up to 18 credits a semester. Fallsession courses are part of fall tuition. Students can take one fallsession course. Those who choose to do that can then take up to 19 total credits as the fallsession courses are done prior to the beginning of fall term. **Students cannot take classes which overlap in times and/or have the same start/end times.**

Most classes will be offered in-person with social distancing measures. Classes that the law school plans to offer remotely are noted.
