# Master of Studies in Law in Ethics & Compliance

Colorado Law's Master of Studies in Law (MSL) in ethics and compliance is a one-year, 28-credit program that enables students who hold at least an undergraduate degree to obtain compliance-focused legal training short of a full juris doctor (JD). No LSAT is required. Part-time options are also available. MSL students range from recent college graduates, to seasoned professionals seeking a second career, to ethics and compliance officers looking to boost their résumés with added credentials.

The MSL in ethics and compliance trains students to drive organizational change and promote a culture of ethics. MSL graduates are prepared to become ethics and compliance officers at large and small corporations in a variety of sectors, growing businesses and startups, financial institutions, or nonprofit entities such as colleges, universities, hospitals, and credit unions.

Public, private, and nonprofit organizations are subject to an increasing number of legal requirements and need trained professionals to lead effective in-house programs to ensure compliance with statutes, regulations, and other applicable laws. Ethics and compliance professionals develop, improve, and manage compliance programs to help organizations obey the law, reduce the risk of fraud and other law-breaking and misconduct, and mitigate their companies' legal liability and reputation risk. They also foster a culture of ethics and responsibility within an organization.

## Curriculum

Students take a combination of MSL and JD courses focusing on specific fields of law such as employment, environmental, privacy and cybersecurity, health care, sports, and financial services. MSL students may also partake in externships for course credit. The program features small class sizes, individualized faculty attention, and the opportunity to take legal coursework at a first-tier law school.

## Careers

Compliance is one of the fastest growing professional fields, with excellent employment potential. The total employment of compliance officers in the U.S. alone is projected to increase by 8.2 percent between 2016 and 2026. According to the U.S. Department of Labor, the median annual wage in 2016 for compliance officers was \$66,540. Graduates of our program have gone on to follow a diverse range of exciting career paths, including health care facilities, the technology sector, and an international investment company.

Compliance officers work in nearly every sort of for-profit and nonprofit organization, ensuring that the entity complies with the governing internal and external laws, regulations, and policies. Compliance professionals are able to harness a diverse array of skills in their work—including analysis, research, communication, creativity, and teamwork—resulting in challenging and satisfying career experiences.

In fields facing complex sets of regulations, such as health care, higher education, natural resources and the environment, the technology industry, and the financial industry, compliance officers are critical. Compliance officers may:

- Identify the risks facing an organization
- Implement policies and procedures to mitigate the risks of an organization violating applicable laws and regulations
- Effectively communicate and market ethics and compliance policies across the organization
- Investigate and resolve internal misconduct and employee complaints
- Help build an ethical organizational culture
- Partner with an organization's general counsel to avoid and mitigate risk
- Advise the organization
