- Rather than traditional course registration, 2L and 3L students allocate points towards classes through two rounds of bidding in the hopes of gaining entry. This allows for a fair process.
- Bidding occurs twice a year for rising 2L and 3L students through two rounds via an electronic submission process in MyCU Info in both fall and spring terms.
- There is no bidding for summer term or fall/wintersession classes.



- Bidding is optional, but strongly encouraged.
- Students are given points to "spend" as they see fit to try to get into classes.
- Only JD students bid. MSL and LLM students do not.
- Points do not roll over from term to term or year to year.



- Bidding Amounts:
 - 1L (rising 2L) students have 1500 bid points.
 - 2L (rising 3L) students have 3000 bid points.
- Bidding for classes allows students a fair process to get into classes.
- After bidding concludes, the Registrar's Office mass enrolls all students in classes they successfully bid on throughout the two rounds of bidding.
- After bidding ends, open enrollment begins (this is when students can start to add and drop classes).

Use the drop down menu and select a course. Then enter a bid and hit save.

To bid on a second class, click on the "Add" button. Enter a bid and hit save.

To delete a class, click on the "Delete" button and hit save.

Each bid must have a unique value, i.e. if you bid 500 points on a class, you may not bid 500 points on another class. It would have to be 499, 501, etc.



The bid below should be saved. You can add more bids by clicking the "Add" button. Once the bids are saved, the "View Lottery Page" may be used.

Make sure you do not overbid for all of your classes. If you accidentally do this, click OK and edit your bids. You will likely need to cancel all of your bids and start over.

Sometimes this causes your points to double their original amount. Contact the Registrar's Office immediately if you see this. You are not allowed to bid more points than you are given by class year.



Preventing Errors

Message

Data being updated does not exist. (18,4)

When trying to save your changes, the system could not find the existing data in the database.

This problem can happen if another user deleted the information while you were making changes. Make a note of what you were doing, then cancel the page and retry.

If the problem persists this may be the result of an application programming error and should be reported to technical support staff.

Possible application errors that could cause this including deleting the data with SqlExec while the record is in the component buffers.

If you try to make too many changes to your bids at once, it will give you an error. Click "OK" and then delete all of your bids and start again.



If you would like to change your bids, go to the "View/Submit/Change Bid" tab. Remember to save often and then go back to the "View Lottery Bids" tab to view your bids.



After Round One Ends



Once round one ends, you can view your bids, but cannot make changes. However, you can cancel bids you made in round one and then make new bids in round two with your remaining points.



After Round One Ends

- Students who allocated points to various classes either make it into the class, are added to the waitlist, or you may receive an error (if you bid too many points or didn't meet a prereq req, etc).
- Depending on how many points were allocated vs. actually needed to make it into a class, points may be returned during round two.
- These points can then be used during round two.

After round one bids are processed, students can see their results by going to the "CU Print/Cancel Bid Results" tab. One of the following statuses will be given for each class:

- GOOD A spot in the class has been earned
 CRED Denied-You bid on more than 21 credits
 SECT You earned a spot in a different section of the same course
 PREQ You do not have the pre- or co-requisite for the course
 TRYD You get this result if you already bid on a class in round one. Remember, if you
 - are on a waitlist, just stay on it. There is no point in placing additional bids on the same class.
 - You have earned a spot on the waitlist for the course. The number listed shows your waitlist position.



Round One Results

- If you received a "GOOD" status you are in the class. <u>Round one</u> winners cannot be displaced by second round bids, even if those bids are higher.
- For example, even if a seat in a course could be secured with only 25 points in the first round, your second round bid of 30 points will not displace any first round winners.



Round One Results

- If you bid on a course that did not fill up, only one point was needed to get in and you are refunded points back.
- If a course did fill up but you bid more than was needed to get in, you received the difference of your bid and the lowest bid that got into the class.
- If you got into a course or on the waitlist for a class you no longer want, cancel the bid in round two and receive your points back.
- You cannot add points to a course for which you are already waitlisted.



Round One Results

- You cannot become enrolled/waitlisted for two sections of the same course. You can bid for multiple/separate sections during round one of bidding. If you do this and both sections of a class are open, the system will accept your bids for the section you bid the highest number of points on.
- If you bid on both sections of a class where one is open and the other would result in a waitlist position, you would be placed in the open class.
- If you bid on a class in round two when you already have a spot in another section of the class from round one, the round two bids will not be accepted. You would have to cancel your round one bid and then attempt to get into the other section.



- 3L students do not have priority in any classes for bidding. This includes things like Ethics, Evidence, seminars, etc. If you still need these classes, make sure you bid accordingly. 1501 points are necessary to outbid all 2L students.
- You can bid on time conflicted courses, but if you are waitlisted after bidding and a seat opens, the system will not enroll you if you still have the conflict. It will skip over you and enroll the next waitlisted person.



- Each student has a unique, randomly generated tiebreaker number. If two or more students bid the same number of points on a course, your tiebreaker number determines whether you are in the course or on the waitlist and in what order.
- If you have registration holds after bidding is over, you risk not getting enrolled in your classes when mass enrollment occurs. Check your account for holds.



- You can bid for up to 21 credits through bidding. However, per ABA standards you can only take up to 18 credits.
- Note that after bidding is over if you are waitlisted and a seat opens in a course, if the system "sees" that enrolling you would put you over 18 credits total, it will skip over you and enroll the next person.
- Most fall and wintersession courses do not count towards the 18 credit cap. However, the system will count it towards your total as far as registration is concerned. Contact lawreg@colorado.edu if you need help with overrides.



- Variable Credit Classes: If a course is set up in the university catalog as a variable credit course, it can be offered at a higher or lower credit amount such as two or three credits.
- This gives faculty the flexibility to offer the class at varying amounts over time. The schedule on the law school website lists the <u>correct</u> credit amounts.
- The bidding system is not smart enough to recognize this variance and will list the course in bidding at the lowest amount possible. So, if a course can be offered at either two or three credits, it is going to show up in bidding as two credits regardless of what the schedule says. You can ignore this when you are bidding. When you are ultimately registered for the course, it will be at the credit amount listed on the schedule. Remember you are limited to taking 18 total credits for the term.



- There are some classes which are not included in bidding such as:
 - Classes with special applications like Education and the Constitution
 - Clinics
 - Journals
 - Independent Legal Research credits
 - Competitions
 - Externships
 - The second semester of a year-long course
 - Anything flagged as "not part of bidding" on the online schedule
