Note: All clinics are not part of bidding and have a special registration form administered through the Clinic Office at <https://cu.law/getclinic>. Applications were due last spring. If the clinic is year-long, students receive credits for both fall and spring term, so, for example if it is noted here as four credits for fall term and four credits for spring term, students receive eight total credits for the year.

2L and 3L students can take up to 18 credits a semester. Wintersession courses are part of spring tuition. Students can take one wintersession course. Those who choose to do that can then take up to 19 or 20 total credits as the wintersession courses are done prior to the beginning of spring term.

Courses with prereqs or those using pass/graded are noted as are any courses with shorter meeting patterns (i.e. 7 wk classes).
