 - "Preserve intellectual record w/ local emphasis"
 - Similarities to FDLP needs and offers policies
 - bit.ly/2ti5WfV
 - "Make informed de-selection decisions"
 - It's easy to declare intent to retain a title (stuff in PASCAL, collections important to
 institution, committed collections etc...) -> make it easier for everyone else to see what
 you're keeping
 - Gold Rush dates back to 2003 (eventually built to include a content comparison system for journal subscriptions)
 - Matching algorithm doesn't rely on OCLC numbers or ISBN/ISSN
 - o grcompare.coalliance.org
 - Match key with MARC record (see handout)
 - can create facets for more specific searching; this now includes SuDoc's
 - Can add/update records by uploading through secure FTP
 - o Tables & charts for comparisons in reporting function
 - o 583 fields for retention commitment notes
 - Sample use cases include: space analysis, comparing holdings for campus program resources, holdings analytics (purchasing info?),
 - Questions from CARL
 - How deep do we index sudocs? (speed vs useful depth)
 - Mismatches (due to spacing, RDA vs non-RDA, etc)
 - "Erring on the side of differentiation" vis-a-vis items in different formats

 - Approved by Senate, has to go through House (stalled at the moment)

 - Concerns, among other things, reproductions of books for print-disabled people, sharing of those reproductions across national borders
 - Talking Book Library: should significantly expand foreign language collection available to patrons, when it's finally in effect in USA
