- 1) Bill of Rights, Introductions, & Future Meetings
 - a. Reading of the 8th Amendment

- 2) Western States Government Information Conference
 - a. Allan talked about the theme and some of the programs (local government)
 - b. Idea - Have representation from all states?
 - c. Idea – Deep dive into the census, for both GOPIG or census
 - d. Perhaps someone from the census expert or official for the keynote? A state demographer?
 - e. Hoping for call for proposals to go out at the end of the month
 - f. Suggestion to add date for the coming year on the website
- 3) FDLP Biennial Survey Results Presentation
 - a. Kate presented the results Biennial Survey Results
 - b. Went through each question (see slides for results)
 - c. Takeaways – fewer depositories are ‘mostly digital’ as some may have expected. This is because it’s too hard to clear out the physical collection. Anyone willing to talk about their experience of the going digital would be welcome to present at a future meeting.
 - d. Any interest in statewide user needs assessment or satisfaction survey, PURL usage tool? Any interest in advocacy documents or some sort of Colorado Depository Library’s Promotional campaign?
 - i. There is interest in understanding how our users’ needs are being met. Might consider a state grant to sponsor a state-wide survey of depository users
 - ii. There is interest in partnering with public libraries since we’ve lost so many of them. Find some way to encourage them to funnel questions to use; provide some sort of centralized web resource/website (using existing libguide or

otherwise). Divide and conquer; all do this in our counties or congressional districts.

- iii. CAL outreach or CALCON would be a great place to start. Lightning talk proposals are open until May 24th.
 - e. Everyone need to change links from FDsys to Govinfo.gov
- 4) Colorado Alliance Updates – Retention policy & Gold Rush
- a. George Macovich visited CU Boulder to show off Gold Rush ERM tool
 - b. Alliance Shared print program; shared retention project (promise to retain books for 25 years)
 - c. Mines is going to do this for Gov Docs
 - d. Something to explore all together
 - e. coalliance.org/faq-library-content-comparison-system
 - f. Perhaps have a meeting to discuss this summer
 - g. Goes hand-in-hand with the preservation steward project (which is super easy to join, according to Kate)
- 5) Modernization of Title 44 (Erik will call in at 11 am)
- a. Erik presented about Title 44 and the amending process
 - b. There is a bill and has been proposed FDLP moderation act of 2018 H.R. 5305
 - c. Bill has been adopted by the Committee on House Administration
 - d. This is different than the draft floating around earlier in the year
 - e. This is not about GPO operations but is mostly about the FDLP, has gained widespread support, no opposition in the House Committee
 - f. Creates a national collection, and that content will be designated by SuDoc
 - g. Expanded role for SuDoc (seems to give them much more regulatory control)
 - h. Look at slides or view DLC Spring Meeting next week.
 - i. Redefinition of Depository Designations: Federal Depository Library (lowest barrier to entry), Selective Depository Library, Regional Depository Library, Preservation Library.
- 6) Discussion of the requirements of to become a part of the preservation steward
- 7) Library Updates
- a. CU law: Lost a librarian, promoted a fellow into vacated positions, announced fellow for next year; CU Boulder: new dean possibly, have approval for a fulltime position for intake specialist and retro cataloging, 2 promotions in govdocs, Head of Gov Info position will be announced, more transitioning cataloging to metadata services. COSPL: State library director will be retiring in June, one book for Colorado kicking off. DU Law: A new assistant Director and new head of technical services. Air Force: John Shewfelt is submitting his resignation, director search has been extended, will be having a new coordinator. UCCS: all positions filled! CO College: Moved into new library, new director, summer will be new focus for govdocs, will have space for more govdocs, 85% cataloged. CSU: New Vet Librarian, TRAIL meeting will be at CSU, tearing down stadium, receiving lots of CDOT library materials. Mines: archives document without shelves. DU: open residency librarian position. Western: space changes, new makers space, women's student lounge, meditation room, old part of the library will be renovated.
