

## PRINICIPAL INVESTIGATOR ELIGIBILITY

**Sponsored Projects Guidance** 

The following may serve as a University of Colorado Boulder (CU Boulder) Principal Investigator (PI) or Co-Principal Investigator (Co-PI) on sponsored projects with confirmation of an active appointment, identifying a commitment to CU Boulder, and in accordance with the chart below. This ensures that CU Boulder has proper controls around those serving in these roles and recognizes that all research endeavors take dedicated commitment. Limited exceptions to the active appointment requirement are identified at the bottom of the chart.

## PI, Co-PI and Approver Acceptance of Responsibility

PIs and Co-PIs of a sponsored project agree to accept responsibility for the scientific and fiscal conduct of the project and to provide all required award deliverables. If project requirements are not properly fulfilled and/or deliverables are not met by the PI and Co-PIs, that responsibility will rest with the approver.

## Notes:

Eligibility status is evaluated at proposal and may be evaluated at award, if needed. Additional restrictions on PI eligibility may apply according to sponsor policies as well as for projects involving classified or controlled unclassified information (CUI).

\*Employees may have working titles that differ from their HR job code title. The job code title is used to determine PI eligibility and any required approvals to serve as PI.

\*\*Effective 4/25/23, CU system added new job codes and titles for working retirees, including "Working PERA Retiree" and "Working ORP Retiree." Pls and Co-Pls with this job code may have a different working title (eg, any of the tenure track or research faculty titles). Regardless of working title, any Pl or Co-Pl with the "Working PERA/ORP Retiree" job code will need approval to serve as Pl or Co-Pl because of the temporary nature of the position (see <a href="APS 5054">APS 5054</a> – Hiring Retirees to Work in Staff or Faculty Positions).
