## **Presidents Leadership Class Board of Advocates:**

The purpose of the PLC Board of Advocates (BoA) is to support the vision, mission, programs, students and alumni of the Presidents Leadership Class (“PLC”) at the University of Colorado Boulder, and to:

- a) Advocate for PLC programs, projects, and students to increase the visibility, vitality, and utility of the PLC program;
- b) Promote and secure financial and other resource development through fundraising
- c) Cultivate an active and engaged alumni community; and,
- d) Counsel PLC staff and faculty on policies, strategies, and programming.

The PLC Board of Advocates is comprised of no less than thirteen (13) and no more than twenty five (25) members. BoA members are elected to serve one, three (3) year term, renewable for up to three (3) terms.

### **Expectations:**

The included document outlines the ***expectations*** for the University of Colorado Presidents Leadership Class Board of Advocates. By fulfilling these commitments and actively engaging, BOA members play a crucial role in advancing the mission and successes of the CU PLC Program.

## **Nomination/Applications Timeline**

Nominations/Applications received by the end of the school year (May/June) will be reviewed by the Nominating & Governance Committee (NGC) of the PLC Board of Advocates. Interviews with potential candidates will take place following committee review of the applications. By August, the NGC will nominate the slate of new Board members to put forward for selection by the Board. Onboarding will then happen in August before the first meeting the next year.

June 22 - June 26: Virtual interviews with NGC

June 27 -July 18: Board approval
