Goals: Recitation aims to develop a more complete understanding of comparative politics and its broad concepts as well as to enhance your specific knowledge of the various countries we cover and how they operate.

Discussion: Recitation will mainly revolve around discussion, which will require your active and enthusiastic participation. Please come to recitation prepared, having thoroughly read the week's assigned text(s).

Readings: There is a large amount of reading that, together with lectures, will provide the necessary background and material for our recitation discussions and assignments.

- The expectation is that you will complete all assigned readings *before* recitation.
- When reading, think about the main argument the author makes. How does the author relate specific ideas with a larger theme?
- If you do not understand something, reread the section, look up words that are unfamiliar and seek advice from fellow students or your TA.

Recitation Grade: Overall, performance in recitation is 20% of your total grade. Actual *attendance* is will comprise 10% of your final grade. The remaining 10% will consist of participation in class discussions and brief assignments, including but not limited to reaction summaries, short answer responses to questions, and short presentations. All assignments will be emailed to you and you should come to class with a hard copy of each assignment to turn in. Assignments turned in late will receive half credit. To perform well in recitation your participation and demonstration of having completed the assigned readings for class are crucial.

Attendance: Recitation attendance is mandatory and is 10% of your final grade. You are permitted one unexcused absence. Beyond one unexcused absence, your attendance grade will be lowered from 100 by 10 percentage points *per absence*. Students with 8 or more unexcused absences will receive an "F" for the *course*.

Current Events: Keep up with ongoing world events, especially in the countries we are studying by reading a reputable international newspaper or print source daily. I recommend the *Economist*, the *New York Times*, the *Washington Post*, and *BBC News* as sources that provide a breadth of quality international news.

Final Note: Recitation is meant to be a helpful, small, discussion-based class in which you feel comfortable to express opinions, ask questions and debate with your fellow students. I am here to help, so if you have a question, problem or need assistance in understanding something related to class come and see me.
