**Goals:** Recitation aims to develop a more complete understanding of comparative politics and its broad concepts as well as to enhance your specific knowledge of different institutions and how they operate in various countries.

**Discussion:** Recitation will mainly revolve around discussion, which will require your active and enthusiastic participation. Please come to recitation prepared, having thoroughly read the week's assigned text(s).

**Readings:** There is a large amount of reading (textbook, country specific readings, additional assignments) that will most certainly be challenging, but will provide the base for our recitation.

- The expectation is that you will complete all assigned readings *before* recitation.
- You will be asked to write or prepare some type of response to each assigned reading that will be specified on a weekly basis.
- When reading, think about the main argument the author makes. How does the author relate specific ideas with a larger theme?
- If you don't understand something, reread the section, look up words that are unfamiliar and seek advice from fellow students or your TA.

**Recitation Grade:** Overall, performance in recitation is 10% of your total grade. Actual *participation* accounts for the majority of your recitation grade and will comprise 70% of the aforementioned 10%. The remaining 30% will consist of short assignments, summary paragraphs and short answer responses to questions, or brief recitation presentations. All assignments will be emailed to you and you should come to class with a hard copy of each assignment to turn in. Assignments turned in late will receive half credit. To perform well in recitation your participation and demonstration of having completed the assigned readings for class are crucial.

**Attendance:** Recitation attendance is mandatory and is 10% of your final your grade. You are permitted one unexcused absence. Beyond one unexcused absence, your attendance grade will be lowered from 100 by 10 percentage points *per absence*. Students with 8 or more unexcused absences will receive an "F" for the *course*. Please do your best to be punctual. Students who arrive over 25 minutes late will be marked as absent while those who consistently arrive after the beginning of class may be subject to an attendance penalty.

**Current Events:** Keep up with ongoing world events, especially in the countries we are studying by reading a reputable international newspaper or print source daily. The Economist, The New York Times, and BBC News are just a few of the many valuable sources your can review.

**Final Note:** Recitation is meant to be a helpful, small, discussion-based class in which you feel comfortable to express opinions, ask questions and debate with your fellow students. I am here to help, so if you have a question, problem or need assistance in understanding something related to class come and see me.
