- **I. Course Description:** Dr. Kanner's lectures and the readings he has assigned will provide the bulk of the informational content of this course. The goal of the recitation sessions will be to provide an environment for continued learning through structured discussion.
- II. Recitation Requirements: Because of the smaller class size, discussion will be an important part of the recitation section.
- 1. <u>Discussion</u>: Students should come to class prepared to discuss the readings assigned for the lecture. You should review the discussion questions at the end of the selections from *Readings in World Politics* that are assigned for each week. I also encourage you to bring questions that relate either to those readings or to the lecture class itself.
- 2. <u>Clickers</u>: Students should bring their clickers to every recitation section as they will be used to facilitate discussion and to assess overall class participation.

VI. Final Comments and notices.

Computers

I highly discourage the use of computers during recitation. I believe that the potential for distraction outweighs the benefit from typing. If you want your notes on your computer, I would recommend transcribing them after class, since this would also give you the benefit of getting another look at your notes. But if I can't persuade you to go for pen and paper, I would caution you to do your best to use your computers responsibly. Important details will come out in the lecture and discussions that I would not want you to miss.

Attendance

If you are not in class, you can not earn any points toward your attendance and participation grade. Clickers, in addition to being tools for discussion and participation, will let me know who comes to class every day. A word of warning: don't give your clicker to your friend to bring in for you. If the clicker attendance doesn't match my independent and verified record, I will investigate the matter. In the event that it was not simply an honest mistake, the incident will be treated as a case of academic dishonesty. Accommodations will be made, however, for excused absences such as a documented illness or for religious observance. Accommodations for all other absences will be discussed on a case-by-case basis. *Note: If you know in advance that you will be missing a recitation, please let me know in advance, too. This will make it much easier to ensure that you don't miss anything from the discussion.

Grade Disputes

Once graded assignments are returned to the class, you have 10 school days to submit to me in writing any dispute you may have with the grade you were given. However, you must first wait 3 school days after you receive the assignment in order to prepare your written dispute and to cool down from the "sticker shock." Then, it is your responsibility to schedule an appointment to explain why it is that you think you scored better than the grade you were given. I will then explain why it is I thought you earned the grade you did. Should you then choose, I will reevaluate your work on the basis of the points from our discussion. However, understand that your grade may go up or down as a result of the review process if additional points come up that were not noted in either the initial grading or our subsequent discussion.

Students with Disabilities
