PSCI 3163-581, AMERICAN FOREIGN POLICY January 23 to May 3, 2012 On Line Course Kanner. On-line

Course Description

The course examines the foundations, assumptions, objectives, dynamics, and methods of U.S. foreign policy since WWII. It gives special attention to domestic and external problems of adaptin U.S. policy to the changing world environment.

Prerequisite: PSCI 2223

- 1. Explain the effect of history on current policy decisions.
- 2. Discuss how policy is result of divided government
 - a. Explain presidential dominance
 - b. Understand Congress' capabilities
 - c. Describe the effect of specific bureaucracies on policy
- 3. Identify how public(s) influence the policy process
- 4. Explain the unique aspects of foreign versus domestic policy

Assessments

There is an assessment (exam) at the end of each Module. You will have <u>only one</u> opportunity to take these assessments. Make sure that you have a good internet connection and that you regularl save your work.

Each assessment consists of a mix of multiple choice and short paragraph questions. Multiple-cho questions usually involve definitions or key concepts from the text website. Short paragraph will usually be variants of discussion questions.

Syllabus quiz

In addition to these graded submissions, you must take and pass the syllabus quiz as well. The syllabus ensures that you understand key points. It is not for grade and you may take it as many times as necessary. The syllabus quiz <u>must be</u> done no later than 13 February 2011.

Discussion/Participation

Comments on the DISCUSSION board are in lieu of classroom discussions. You should post your thoughts on the questions and comments of other students. If I respond to your posting with a question, you should answer the question.

Just as you need to be on time for classes, you should participate in the discussions in a timely manner. That is why grades for each post will only be given full credit (2 points) if they are prior t the suggested completion date. They will be given partial credit (1 point) for a week after that. Postings after that week will not be given any credit.

Course Conduct

How To Study.

CULEARN organizes classes by Modules. These correspond to parts of your textbook. Each module has a set of pages or lesson guides to help you study. A typical guide contains

- Study questions designed to direct your readings;
- The *Reading Assignment* from the textbook;
- Additional Activities which may be a video or outside readings;
- The Discussion Question which you are asked to comment on; and
- Key Terms and Concepts that you need to know.

Preparing and Taking exams

The best way to prepare for the exams is to review the key concepts (or definitions) at the course website (there is a section labeled "Key Concepts" under each chapter). Although I do not use the same questions, the chapter quizzes (found under the "Quizzes" section) are a good check and preparation.

My experience is that students that take all the assessments at the last moment tend to do poorly o miss the deadline entirely. You are also at danger in running out of time due to internet access

problems and unplanned shut downs of the CULEARN website.

Planning

Although the course is self-paced, you need to develop a routine and a discipline towards the cour I have included suggested completion times to help you. To stay on track, you should plan to spen between 50 to 60 minutes a day on the course.

Suggested Completion Date
