Course Description

Topics include the justification of defensive, pre-emptive and preventive wars; humanitarian intervention; the combatant/noncombatant distinction; the distinction between direct and "collateral" harm to civilians; sieges, blockades and economic sanctions; guerilla warfar; terrorism and reprisals; supreme emergency and torture. There are two main texts for the course. The frist is *Traditions of International Ethics*, eds. Terry Nardin and David R. Mapel. The second is Michael Walzer's *Just and Unjust Wars*, which develops a contemporary version of just war theory by working through a wide range of historical cases. Readings will include critical essays on various topics by a number of other philosophers and political theorists. Readings are listed below and will be available on-line and/or on reserve.

Course Requirements

Reading outlines with critical comments and discussion questions: 10% of final grade; 1.5 -2 pages minimum for each article assigned, typed, double-spaced. Summaries will be assigned in class to students on a rotating basis. No late summaries accepted. More than one unexcused failure to submit a summary on time results in failure of this part of the course.

Class participation: 10%. Class participation includes attendance, careful reading, taking an active part in class, and leading class discussions on days you are assigned to summarize the reading. Failure to attend more than 50% of class results in failure of the *entire* course.

Mid-term exam: 20%.

Paper: 30%. Fifteen-twenty pages, typed, double-spaced, standard format: one-inch margines, Times New Roman font, MLA or Chicago style footnotes. Students can choose between one of several topics suggested throughout the semester or write on a topic agreed upon with the instructor. Paper topics must be agreed upon and discussed at least once with instructor prior to a set date TBA.

Final exam: 30%.

All assignments except must be completed on time to pass the course unless the student has a documented excuse.

Dates for all assignments given in reading schedule below and subject to change by instructor (as is everything in this syllabus).

Make up assignments will be permitted only if a student can provide documentation for an excused absence (e.g..a doctor's letter or documentation for other kinds of absences allowed under University policy).

You can use different methods, from author name, volume/issue, etc. In many cases your best bet is to try "JStor". There are several additional articles by Walzer that are not in *Just and Unjust Wars*, so don't get confused. The few articles that cannot be found online, e.g., chapters from a book or essays from an especially obsure journal, can be accessed by a link I will put on line or you can get some of these articles by going to my protected page of readings: go to http://sobek.colorado.edu/~mapel/PROTECTED Then look for articles in the folder "Just War".
