Courses Taught

Social Psychology (PSYC 2606): Fall 1998, Spring 1999, Fall 1999, Spring 2001, Fall 2001, Spring 2003

Description: This lower division, introductory-level core class provides an introduction to basic concepts in social psychology. In addition to specific content, I introduce a handful of themes (e.g., that we like to feel good about ourselves, that we often default to more automatic thinking), then refer back to them throughout the class to illustrate the common processes that govern social behavior. I also place a lot of emphasis on how social psychologists do science, developing students' understanding of how one tests hypotheses and evaluates the validity of different explanations.

Research Methods in Psychology (PSYC 3111): Spring 2017

Description: This core class is required of all psychology majors, and focuses on teaching students to design, conduct, analyze, and present (both verbally and in writing) empirical research psychology. The class contains both a lecture and lab component. There are many active learning components (e.g., in-class group activities, in-class quizzes, use of clickers). Students also work hands-on with research through the analysis and presentation of two studies, which of which they design from scratch and collect all the data.

Psychology and Biology of Emotion (PSYC 4606): Spring 2000, Spring 2002, Fall 2002, Spring 2004, Spring 2006, Fall 2010

Description: Emotion is one of the most cross-disciplinary topics in psychology. I teach this upper division undergraduate seminar like a capstone class, discussing emotion from all perspectives in psychology. I also foster critical thinking by assigning research articles and having students complete many short reaction papers about them, as well as two longer papers based on mini experiments.

Social Neuroscience (PSCY 4606, now PSYC 4526): Spring 2015 (2 sections), Fall 2015
Description: This upper division advanced graduate seminar introduces students to the interdisciplinary topic of Social Neuroscience. Students read 2-3 empirical articles a week. Class is devoted to critically discussing the research and understanding the theoretical implications.

Introduction to Social Neuroscience (PSYC 5606): Fall 1999, Fall 2001
Description: This graduate proseminar taken by all students in the social psychology program provides an advanced introduction to key theoretical issues in social neuroscience.

Psychophysiological Methods (PSYC 5606): Fall 2000, Fall 2002, Spring 2005, Fall 2008, Fall 2010
Description: This graduate proseminar taken by all students in the social psychology program is the methods complement to *Introduction to Social Neuroscience*. I do weekly labs in which students collect, analyze, and interpret physiological data.

Emotions and Intergroup Relations (PSCY 5606): Fall 2003, Fall 2005
Description: A graduate proseminar focusing on new research on the role of emotions in intergroup perception and relations.

Emotion (PSYC 5606): Spring 2008, Spring 2010, Fall 2011, Fall 2012, Fall 2014
Description: A graduate proseminar providing a basic overview of major theoretical traditions in the study of emotion.

Professional Development (PSYC 6606): Fall 2011, Spring 2012, Fall 2016, Spring 2017
Description: This class focuses on skills and knowledge relevant to graduate training by providing a forum for students to give research talks as well as discussion of topics relevant to professional development (e.g., how to prepare job application materials, how to start your first lab).

Theories and Research in Emotion (PSYC 7536): Spring 1999, Spring 2004
Description: A more in-depth graduate seminar on emotion that starts with early writings on emotion (James, Darwin), then covers contemporary research.

Current Research in Stereotyping and Prejudice (PSYC 7536): Fall 1999, Fall 2000
Description: An informal graduate seminar, mostly focusing on providing students with feedback on presentations of their research, design of new studies, and comments on manuscripts.

The Social Brain (PSYC 7536): Spring 2003, Spring 2006, Fall 2008, Spring 2013, Fall 2015
Description: The goal of this graduate seminar is to give students with diverse backgrounds a basic grounding in both social psychological theory and neuroscience while covering the latest research in social neuroscience.
