Do you need an enrollment verification for Fall 2014? Get yours *free* in one of three ways:

- Request it in person at the Office of the Registrar (bring your Buff OneCard).
- Email a request to registrar@colorado.edu (include your full name and student ID number).
- Log in to [MyCUInfo](#) to access the Student Self-Service Site.

The Student Self-Service Site by the National Student Clearinghouse is available to CU-Boulder students for free via MyCUInfo. Use it to:

- Print enrollment verification certificates to send to health insurers, housing providers or other organizations requiring proof of your enrollment ([step-by-step instructions](#)).
- Check the deferment forms and electronic notifications sent to your lenders.
- Obtain a list of your student loan lenders and link to real-time loan information.
- View your enrollment history.
- View enrollment verifications provided to student service providers at your request.

If the National Student Clearinghouse verification does not meet your needs, you may obtain a specialized verification through the Office of the Registrar.
