### Registrar's E-memo (Crystal Eilerman)

1) The following e-memo was sent on Tuesday, Jan. 13, to students who had not created a security passphrase.



Dear [first],

You have not set a security passphrase in MyCUInfo. Without a security passphrase, the university may not disclose any personal (non-directory) information to you over the phone or in person without a photo ID. Messages sent from your @colorado.edu email address do not require a security passphrase for correspondence.

#### **Set Your Security Passphrase**

Visit the <u>Security Passphrase</u> page for step-by-step instructions. Your passphrase can be up to 50 alphabetical characters (numbers, symbols and special characters are not accepted), and should be easily remembered but difficult to guess. Do not use your IdentiKey password. If your passphrase contains lewd, intimidating, abusive or threatening language, you may be refused service and referred to the Office of Student Conduct.

### **Third-Party Access**

Do not share your security passphrase with anyone. If you want a third party (e.g., a parent, grandparent or sponsor) to have access to your record, you must visit the Office of the Registrar in person and complete a Student Permission Form to authorize release of non-directory information to a third party.

As required by the Family Educational Rights and Privacy Act (FERPA), CU-Boulder is committed to protecting your educational record by limiting disclosure of your personal (non-directory) information.

2) The following e-memo was sent on Thursday, Jan. 15, to students who applied to graduate in Dec. 2014.



Dear [first],

If you graduated in December 2014, be sure to meet the following deadlines to receive your diploma!

#### Jan. 22: Last Day to Update Your Diploma Name and Diploma Address

Update this information in MyCUInfo. Click **Apply for Graduation** and follow the prompts (even though you already applied) until you see your name and address listed, and edit them there.

If your Diploma Address is not accurate by this date, you will not receive your diploma. USPS does not forward diplomas. If your Diploma Name is not accurate by this date, it can only be corrected by ordering a <u>replacement diploma</u>.

## Jan. 23: Sign up for Direct Deposit to Receive Your Confirmation Deposit

To receive your <u>confirmation deposit refund</u>, minus any outstanding debt, you must set up a <u>direct deposit</u> transaction specific to your confirmation deposit (separate from payroll). The Bursar's Office <u>How To's</u> provide step-by-step instructions. Refunds will be directly deposited into your bank account around the first week of February. If you have questions about direct deposit, email <u>bursar@colorado.edu</u>.

### Jan. 30: Last Day to Clear All Financial Holds

You will not receive your diploma unless <u>all financial obligations</u> (e.g., fines, tickets, fees) are paid. You can view your student account and pay online in <u>MyCUInfo</u> or by visiting the Bursar's Office. If you have questions, email <u>bursar@colorado.edu</u>.

### Jan. 30: Degrees Post to Transcripts

Official transcripts can be <u>ordered online</u>. Unofficial transcripts can be viewed in <u>MyCUInfo</u>. If you have transcript questions, email transcriptinfo@colorado.edu.

### Feb. 24: Diplomas Mailed

Registrar Network, 1/20/2015

If you did not enter a Diploma Address in your MyCUInfo profile, your diploma will be mailed to your Home Address. Remember: The post office does not forward diplomas.

Welcome back! The following is a summary of Spring 2015 dates and deadlines for Main Campus, full-semester courses. For a comprehensive list, see the <u>Official Academic Calendar</u>. All deadlines occur at 11:59 p.m. unless otherwise noted.

## Wednesday, January 21, 2015

Last day to add a course via MyCUInfo.

Last day to add your name to a course waitlist.

Last day to apply for Time-Off/StayConnected and be eligible to purchase university-sponsored insurance (5 p.m.).

Last day to waive health insurance.

## Wednesday, January 28, 2015

Last day to drop a class without tuition/fee charges and without a W grade.

Last day to withdraw from the university without tuition/fee charges and without a W grade. A \$200 processing fee applies.

Other events: Last day to waive CUSG fees (5 p.m.) or to request a refund for student opportunity fees (5 p.m.).

## Friday, January 30, 2015

Last day to add a class for College Opportunity Fund (COF) funding (5 p.m.).

Last day for students not currently enrolled to register without a late fee.

Last day to change variable credit hours and pass/fail & no-credit status via MyCUInfo.

# Thursday, February 5, 2015

Payment deadline for tuition and fees for spring semester.
