Student Name Display Error on Student Services Center Admin View (Sarah Layton)

Occasionally, when accessing the student's FERPA Directory Information and Security Passphrase via Student Services Center Admin View, the name that displays after you click on the FERPA Window Curtain is not the student's name. The student's name correctly displays if the FERPA Window Curtain is clicked from another page in Campus Solutions.
