Dropping Versus Withdrawing (Rebecca Jones)

If a student is trying to drop a class or withdraw from CU-Boulder, please be sure to differentiate between the two actions and confirm the student's intent; each has a different impact on tuition and fees.

- Withdrawing: The student wants to drop all classes for the semester. Students who withdraw from now through Oct. 7 are assessed <u>60 percent of tuition and fees</u> and receive W grades. After Oct. 7, students who withdraw do not receive a refund.
- **Dropping**: The student wants to drop one or two classes, but keep taking other classes for the semester. Students who drop a class after Sept. 9 receive a W grade and <u>no refund</u> of tuition or fees. Students can drop classes online through their MyCUInfo portal until Oct. 30 at 11:59 p.m. After Oct. 30, students need to petition their college/school/program for a late drop.

Unofficial Noncredit Transcripts Now Available in Self-Service (Julie Michalowski)

New functionality is in place for students to view their unofficial noncredit transcript via self-service. The noncredit transcript only displays coursework with the career of noncredit (NOCR), such as Intensive English Program courses (NCIE) in the International English Center. At this time, auditors (senior or community) are not able to access this, because their coursework is listed in an undergraduate or graduate career.

The following e-memo was sent on Friday, Oct. 2, to all students with a Selective Service hold.

Office of the Registrar UNIVERSITY OF COLORADO BOULDER
Dear [first],
A hold has been placed on your account because you did not complete one or both steps of the Selective Service requirement.
This hold will remain on your account until you comply and will prevent you from registering for classes. The Selective Service requirement needed to be fulfilled with both the state and the university by Thursday, October 1, 2015.
What Is the Selective Service Registration Requirement? With only a few exceptions, the Selective Service registration requirement applies to all male U.S. citizens and male immigrants residing in the United States who are 18 through 25 years of age (Colorado House Bill 1021, effective July 1, 1987).
What You Need To Do NOTE: All CU forms require <u>Adobe Reader</u> . Mac users MUST install the free Adobe Reader software for forms to work.
 Register online with Selective Service. Go to the <u>Selective Service</u> website. Click Register, then Register Online. Complete and submit the form.
 Submit the Selective Service Verification Form. Log in to <u>MyCUInfo</u>. Under Other Academic Services (bottom of page), click Selective Service Form. Complete and submit the form.
The verification form will be processed and the hold removed the next business day. You may file a statement with Selective Service indicating your position as a Conscientious Objector; however, you're still required to complete the Selective Service Verification Form and submit it to the university.
