### **Preregistration Items**

Before your enrollment appointment begins, click on **Register for Classes** in MyCUInfo to complete your preregistration items. For more information, click on **Holds and To-Do Items** or visit [Complete Your Preregistration Items](#).

### **Summer Financial Aid**

The Summer Financial Aid Application will be available in MyCUInfo beginning Wednesday, Feb. 24. If you're interested in receiving work-study, please apply early; summer work-study is limited and is available first-come, first-served. See [Apply for Aid: Summer School](#) for details.

### **MyCUInfo App**

After you use MyCUInfo to complete your preregistration items and plan your schedule, download our mobile app to make quick, limited enrollment changes on the go, like adding or dropping a class.

Has your insurance company or other provider requested verification of your college enrollment? If so, get your Spring 2016 enrollment verification for free without a trip to the Office of the Registrar.

Simply log in to [MyCUInfo](#) and click **Enrollment Verification**:



This will launch the National Student Clearinghouse Student Self-Service Site, where you can:

- Print free enrollment verification certificates to send to insurers, housing providers or other organizations requiring proof of your enrollment ([step-by-step instructions](#)).
- View your enrollment history.
- View the student loan deferment notifications sent to your lenders and guarantors.
- View the proof(s) of enrollment sent to your insurers or other providers at your request.
- Obtain a list of your student loan lenders and link to real-time loan information.
