Residency petitions for each semester are accepted only during a specified period of time. The acceptance window for Summer and Fall 2016 petitions began on April 1. The deadline for Summer 2016 petitions is May 13 at 4:30 p.m., and the deadline for Fall 2016 petitions is July 25 at 4:30 p.m.

Please note that petitions no longer need to be notarized, but the petitioner's signature is still required.
