## Staff Spotlight #5: Julie Michalowski

Julie has worked in the Office of the Registrar for 19 years, and is one of our two CU-SIS development coordinators.

Beyond her responsibilities for CU-SIS maintenance and end-of-term processing, Julie has led testing, troubleshooting and documentation for several high-profile CU-SIS projects, including the [MyCUInfo app](#) (launched in August 2015) and [CU Guest Access](#) (soft launched in April 2016).

### About Julie

**Childhood home:** Midwest corn country. I was born in Iowa and grew up mostly in Shabbona, Illinois, a small town about 65 miles west of Chicago with a current population of 950.

**Background:** My parents owned a family drive-in restaurant for at least a decade, which contributed to my dedicated work ethic. After college, my jobs ranged from medical transcriptionist to commercial bank teller. I worked for Northern Illinois University for a few years and really enjoyed the campus experience, which later drew me to CU.

**What brought you to Boulder?** In September 1982, I came to visit a friend who was attending CU after finishing a summer job at Glacier National Park. I fell in love with Colorado, applied for a few jobs, and returned before the first winter snow arrived. In 1988, I broke away to explore Southern California. Although I enjoyed the ocean view, I missed the Colorado mountains, so I came back in August 1991.

**What appeals to you most about working with student records?** I enjoy the detail-oriented intricacies of student records. Although most of my contributions are behind the scenes, it's satisfying to contribute to a positive student experience.

**Tell us about CU Guest Access.** Delegated access to student records was first discussed a few years ago. I thought the project sounded interesting and challenging, and it was exactly that. I started attending planning meetings in April 2015, and after many hours of testing and retesting page display tweaks and student/guest functionality, we soft-launched in April 2016. I can still hear the testing phrase "clear your cache" echoing around my workstation. All the hard work that went into this feature from different campus entities has surely paid off.

**Where might we find you outside of work?** Spending time with family and friends; walking my dog, Peanut; hitting the penny slots; or reading and sipping on a glass of wine.
