Submitting Special Action Forms (Office of the Registrar)

When submitting a Special Action Form (SAF) to change a student's schedule, please make sure to check all necessary overrides. Unmarked overrides cause processing delays, frustration for students and extra work for everyone involved.

Some commonly missed overrides:

- Closed Class Must be checked to add or swap a student into a closed section of a course.
- Requisites Must be checked if dropping a student from a course that is a co-requisite for another course the
 student is still enrolled in. Requisites must also be checked when swapping sections of a course that require this
 override.
- **Time Conflict** Must be marked to enroll a student into a class that overlaps with another class they are currently enrolled in.

Changes Coming to Final Exam & Commencement Schedule (Sally Page)

As <u>announced</u> by the chancellor and provost in yesterday's CU Boulder Today, adjustments are coming to the traditional final exam, recognition ceremony and commencement schedule starting in 2017–18.

To summarize, starting in Fall 2017, the last day of classes will fall on a Thursday, followed by a reading day on Friday, and final exams from Saturday through Wednesday. In fall, both Thursday and Friday will be available for college, school and departmental recognition ceremonies.

Starting in Spring 2018, the campuswide commencement ceremony will be held on Thursday morning, followed by college, school and departmental recognition ceremonies.

Happy National Voter Registration Day! Register to vote now to have your voice heard in the November election.

Register to Vote in Your Home State

Colorado law allows college students to register to vote in their hometown if they choose. Access your state's voter registration form through the <u>U.S. Election Assistance Commission</u>, and be sure to request an absentee ballot before Election Day.

Register to Vote in Colorado

Register to vote online through the <u>Colorado Secretary of State</u> website, or mail a completed <u>paper form</u> to your county clerk's office. If you'd prefer to register in person, visit <u>Go Vote Colorado</u> to find your local voter service and polling center (click **Find my polling location** and enter your information).

All active, registered Colorado voters automatically receive a ballot in the mail a few weeks before Election Day. If you choose to vote in person, you'll need to present an <u>acceptable form of identification</u> and surrender your mail ballot.

If you register to vote in Colorado, please be aware that doing so will make you eligible for jury duty. A jury summons is rarely excused for students, even during final exams.

We sent the following e-memo on Wednesday, Sept. 28, to students who were required to register for Selective Service but had not yet done so.



Dear [first],

Our records indicate that you still have not completed one or both steps of the <u>Selective Service</u> registration requirement.

You must fulfill this requirement with both the state and the university by **11:59 p.m. on Wednesday, Sept. 28, 2016.** Failure to submit this form will result in a registration hold being placed on your account, preventing you from registering for classes.

What Is the Selective Service Registration Requirement?

With only a few exceptions, the Selective Service registration requirement applies to all male U.S. citizens and male immigrants residing in the United States who are 18 through 25 years of age (Colorado House Bill 1021, effective July 1, 1987). Conscientious objectors are still required to register with the Selective Service System.

What You Need To Do

Complete the following steps by **11:59 p.m. on Wednesday, Sept. 28, 2016**. NOTE: All CU forms require Adobe Reader. Mac users MUST install the free Adobe Reader software for forms to work.

- 1. Register online with Selective Service.
 - o Go to the Selective Service website.
 - o Click Register, then Register Online.
 - o Complete and submit the form.
- 2. Submit the Selective Service Verification Form.
 - o Log in to MyCUInfo.
 - Under Other Academic Services (bottom of page), click Selective Service Form.
 - o Complete and submit the form.

The verification form will be processed and the hold removed the next business day; this is not an automatic process.

Dear [first],

A hold has been placed on your account because you did not complete one or both steps of the Selective Service requirement.

This hold will remain on your account until you comply, and will prevent you from registering for classes. The Selective Service requirement needed to be fulfilled with both the state and the university by Thursday, Sept. 29, 2016.

What Is the Selective Service Registration Requirement?

With only a few exceptions, the Selective Service registration requirement applies to all male U.S. citizens and male immigrants residing in the United States who are 18 through 25 years of age (Colorado House Bill 1021, effective July 1, 1987). 

Dear [first],

Has your insurance company or other provider requested verification of your college enrollment? If so, get your Fall 2016 enrollment verification for free without a trip to the Office of the Registrar.

Simply log in to MyCUInfo and click Enrollment Verification:



This will launch the National Student Clearinghouse Student Self-Service Site, where you can:

- Print free enrollment verification certificates to send to insurers, housing providers or other organizations requiring proof of your enrollment (<u>step-by-step instructions</u>).
- · View your enrollment history.
- View the student loan deferment notifications sent to your lenders and guarantors.
- View the proof(s) of enrollment sent to your insurers or other providers at your request.
- Obtain a list of your student loan lenders and link to real-time loan information.
