CORs Required for Fall 2016 Late Adds or Swaps (Office of the Registrar)

The deadline to submit Special Action Forms (SAFs) for Fall 2016 late adds and swaps was yesterday, Monday, Dec. 5, at 5 p.m. Office of the Registrar staff will return any SAFs for late adds or swaps received after this date.

After Dec. 5, requests for late adds or swaps must be submitted using a Change of Record Form (COR) that includes both the student's final grade and the dean's signature.

Fall 2016 COF Deadlines (Office of the Registrar)

The last day to apply for COF is the last day of classes (Friday, Dec. 9), and the last day to authorize COF is the last day of finals (Thursday, Dec. 15).

Fall 2016 Last Day to Withdraw from the University (Ginni Mulder)

With the Fall 2016 semester coming to an end, students have until 5 p.m. on the last day of classes (Friday, Dec. 9) to submit a withdrawal form and drop all Main Campus classes.
