The **Office of Research Integrity (ORI)** and Compliance ensures students, faculty and staff involved in research uphold CU Boulder's commitment to scientific and ethical integrity.



Human Research & IRB

The Institutional Review Board (IRB) at CU Boulder is responsible for **the review of all human subject research** when conducted by the university's faculty, staff, students or other affiliates and agents.

The IRB seeks to create a collaborative relationship with the research community to assure that research with human subjects is conducted in accordance with legal requirements and the ethical principles of Respect for Persons, Beneficence and Justice.

Conflicts of Interest & Commitment

CU Boulder encourages innovation, scholarship and research that lead to commercial and consulting activities and global engagement. Such activities, however, have the potential to create **conflicts of interest and commitment**.

All faculty, and any other employee or student with responsibility for the design, conduct or reporting of research must disclose all significant (financial and foreign) interests and external professional activities that could compromise (or appear to compromise) university decision-making or duties.

Controlled substance use in research and teaching activities is managed through a decentralized process at CU Boulder. If you are conducting **research or teaching activities that involve controlled substances**, you must comply with applicable federal and state laws and regulations.

Export Controls

The Office of Export Controls (OEC) helps faculty navigate federal **export control laws and regulations**—which, if applicable to your research, will determine how you use and share equipment, materials, software and technology within your lab. They can also limit how you collaborate with foreign colleagues.
