The presentation should include a brief introduction and enough background on the experiments presented to ensure that a non-expert audience can follow the presentation.

PAPER CRITIQUES : Papers will be assigned to read and evaluate. Each student will write a onepage critique detailing the main point(s) of the paper and the strengths and weaknesses of the results and conclusions. These critiques will be discussed in class and everyone should be ready to lead the discussion when asked by the instructor.
