This project documents mortality risk among gang members, an understudied but extremely high-risk subpopulation in the United States. Gangs are street- and youth-oriented groups that share a collective identity and engage in high levels of criminal or delinquent activity. As much as 8% of the population has a history of gang involvement by their early twenties, and gang members are disproportionately male, black or Latino, low socioeconomic status, and located in urban environments. Prior studies have reported mortality statistics on gang members, but this research suffers from small sample sizes of gang members and deaths, sometimes crudely constructed comparison groups or the absence of a comparison group, and a lack of systematic data collection on mortality, including cause-of-death. We are conducting the most comprehensive investigation into the gang membership-mortality association extant.

Our core services—Administration, Development, and Scientific/Technical Research Support—sustain research quality and quantity; provide demographic mentoring and training, especially to junior investigators; encourage collaborative and interdisciplinary demographic research; facilitate interaction among researchers nationally and internationally; promote dissemination of demographic research; and build bridges among departments, institutes, programs, centers, and universities.
