Course Description:

In this course students develop advanced Spanish-language competency and transcultural knowledge and skills for health-related contexts both within the U.S. and abroad in order to develop a critical apparatus for analyzing, reading, listening, and speaking and writing about health and health fields in historical and socio-cultural contexts. Specifically, the course aims:

- To provide students with advanced communication strategies and a solid foundation in health-related communication through exercises with a communicative approach and the practice of health-related terminology. The course will include practice with interviewing and basic interpreting. In addition, students will learn to understand and begin to create basic documents and appropriate internet and social media information (e.g. informational and educational fliers, insurance documents, consent forms).
- 2. To familiarize students with the needs of Spanish-speaking patients within different **professional health services contexts,** ranging from patient centered fields (clinical, public health, counseling) to health management and policy issues.
- 3. To integrate student's knowledge of health issues with the **geographic contexts** of the Spanish-speaking countries, including geographic patterns related to the diverse Latino populations of the United States.
- 4. To integrate the above-mentioned language, professional and geographic contexts with **cultural contexts** (e.g. cultural construction of illness, issues of health access, folk medicine) pertinent to providing health services to Spanish-speakers in the U.S. and abroad.
- 5. To allow students to **demonstrate research skills** by developing a project on a particular research topic not presented in class and presenting this project in a formal oral and written format.

Administrative Information:

Students enrolled in this class must have completed Spanish 3000 and earned a grade of C- or better.

Course Requirements:

1) Homework: You will have a reading, video, and/or writing assignment for each day of class. These assignments are to be completed <u>before</u> class so that class time can be devoted to working with the new concepts and vocabulary. All written assignments to be handed in must be completed via Canvas by the assigned deadline. I will lower the grade of an individual assignment 10% per 24 hours late.

2) Health news/country reports: Students will research assigned categories of information about countries based on the instructions in the book and you will present this research orally.

3) Semester final project: Health Information Presentation with accompanying text and power-point or presi for on-line distribution to the class:

A. Context and Theme: Each student is responsible for 1) selecting a medically relevant topic related to their own personal academic/professional goals, 2) clearly defining the medical/health setting both in terms of geographic location and mode of contact between medical professional and target audience, 3) researching the topic, 4) devising a lesson on the topic (7-10 minutes), and 4) presenting it to the class. Examples of topics include: tobacco cessation, diabetes in pregnancy, dental hygiene, a mental health topic, and the impact of environmental factors on health in a local community. The lesson will be given as though you were a medical professional presenting the topic to the target patient population. For example, if you are researching diabetes in pregnancy, the lesson you will prepare will mimic one that a patient may have to attend at her doctor's office or if you are researching community public health in relation to dietary practices, the lesson you will prepare will mimic one that a community might have access to through an on-line video or at a community health fair. Please address general medical aspects of your topic, relevance to the Hispanic/Latino patient population, cultural competence aspects, and helpful medical/health advice.

B. You will need to prepare a short lesson plan, in Spanish (2-4 pages, double spaced, Times New Roman, 12 font) that you will turn in. You should use PowerPoint or Presi to present your material and handouts. You will post these materials to Canvas.

5) Quizzes, Mid-term and Final Exams. There will be 6 quizzes, 2 mid-terms, and a final exam. All of these will be administered during class.

6) Attendance: Perfect attendance is expected. Four absences (for whatever reason, <u>including medical reasons</u>) are allowed with no penalty. Starting with the fifth absence, your final grade will drop 2% for each additional absence. Please inform your instructor immediately if you have a problem that will impact your attendance.

7) Common Courtesy: Please do not enter class late. Please do not request to leave early. If you arrive more than 10 minutes late to class, I will consider it an absence. If you leave class more than 10 minutes early, I will consider it an absence.

8) No cell phone calls, texting, emailing or Facebook. If you text, check e-mail, and/or check Facebook, or other sites not related to the class, I will consider you absent for that class and an absence will be assessed against your final grade.
