- Shared Governance and Campus Partners:
 - \circ $\hfill Training and focus on racial discrimination$
 - Leadership wants to hear from campus groups
 - Board of Regents want to hear from campus groups
 - Teresa Hernandez is now in a new roll looking for diversity in the talent search for HR
 - Admissions: campus visits in fall and consistency in similar jobs across campus being asked to come back to campus.
 - Some rolls have been asked to come back whereas other, similar positions, have not
 - HR working on building more consistency in how that policy is being applied across campus

Vice-Chairs Report:

- First Speaker Series: 282 people showed up
- Haven't started working on the next one yet, but we have a list of about 6 speakers as ideas for the next Speaker Series
- It was a good space for Pat to address the concerns
 - \circ $\,$ A lot of questions were brought back to the directors, but it was a good space to get those asked

Treasurer's Report:

- If we put everything in we will be \$27,128 in the red
- The budget situation for the university is still very uncertain for FY21
 - \circ $\;$ We'll new more after the census date
 - \circ $\:$ If we are looking at this deficit we'll have to use half of our R & R to cover it
 - In the fall semester we would propose to look at half the budget now and then look at it again in December
- We want to use our budget, but we also want to be sustainable
 - Column K is what was asked for last year
 - I hope everyone is not feeling blindsided by this, but being aware that in the past few years we've dipped into the R&R a lot.
 - Protect the R&R more than we have in the past to protect the Staff Administrator salary
 - \circ ~ We don't know what Spring is going to look like, there is just so much uncertainty
 - Today approve half of the budget allows committees to start doing work and allow us to see what our actual spend is
 - If other things do come up this fall engage with Shelby to work on what the next step would be
 - This will allow us to see how campus will be looking for the remainder of the year
- Executive Committee will take this up for discussion at the August 26, 2020 Executive Committee meeting.

Secretary's Report:

- No one added anything to the pulse this week, but if you do have anything to share out that form is available
- If you haven't submitted your delegate report please do so soon

Parliamentarian Report:

- We didn't ask for any abstains for Council members on adopting the meeting minutes
- As parliamentarian I have some concerns that Roberts Rules come from a culture of white supremacy so if anyone knows of any alternative avenues we can explore, please let us know.
 - \circ $\;$ $\;$ Plenty of room for improvement, but it seems to be the best option available at this time $\;$
 - It is about inclusiveness

- Resolution by Regent Kroll to talk about diversity and inclusion
 - \circ $\;$ Shot down an into a committee, but still in talks
- Got approval for a part time Admin for UCSC
- Discussed 5% budget cuts, in UCSC it is being taken from travel and food for events
- Talk that some staff will need to stay home to tutor kids and the affect that will have on leave
 - We would like to keep it on our radar
- Concern that will not be an enforcement of PPE on campus
 - \circ $\;$ If certain people will be required to be the "mask police" and who would enforce those policies
- Nominations for Staff Awards:
 - \circ $\;$ Working on if we have a list of the candidates that were nominated previously so we don't double up
 - \circ ~ Tara will share that with Lauren and Lauren will share it out
- <u>The Regent meetings are mostly open to the public and they are all recorded</u>

New Business:

- Motion to add Representatives to Council for the remainder of FY21:
 - \circ $\,$ Discussion: Amend to say the remainder of year instead of current year on the verbiage
 - They would be designated as Appointed At-Large
 - \circ Vote:
 - Amendment Passes
 - Motion to approve amended
 - 22 yes votes, motion passes
- Motion: That a prominent banner be added to all future Staff Council electronic communications (emails, newsletters, and the SC webpage home) regarding our continuing commitment to antiracism efforts, and the exact wording and design of the banner be tasked to the Inclusive Excellence committee.
 - \circ $\;$ Inclusive Excellence will look into this and bring it back at a later time $\;$
 - \circ $\;$ Discussion: It is important to put this front and center $\;$
 - It is important, but it needs to be done in the right way and planned out
 - Inclusive Excellence Committee is supportive, but agrees it needs to be planned out
