Served multiple terms as part of a small, three-person senior leadership team. The Associate Dean for Academic Affairs reports to the Dean of the Law School and has primary responsibilities for administering the academic program of the law school including: oversight of permanent faculty; advising the Dean; recruitment, hiring, and oversight of non-permanent faculty; managing faculty teaching loads; overseeing curriculum development; resolving conflicts among faculty and between faculty and students or staff; advising students, particularly at-risk students; ensuring compliance with accrediting bodies; and serving on most major law school committees.

Resource Management

- Managed the school's budget (approximately \$1 million) for non-permanent faculty; recruited faculty, negotiated contract terms, and oversaw teaching for approximately 60 non-tenure track professors
- Managed annual disbursement of approximately \$140,000 in faculty travel funds for tenured and tenure track faculty
- Managed a 20% decrease in permanent, tenured or tenure-track faculty members mandated by the Board of Trustees' Strategic Transition Plan (through attrition only) without sacrificing educational quality and without overreliance on contract faculty

My scholarship focuses on women's rights in sub-Saharan Africa, women's rights within the United Nations, and the application of critical race feminism in the context of human rights. My forthcoming book with Oxford University Press is the culmination of more than two decades of scholarship related to intersectionality in global human rights. Highlights of my work beyond the classroom include organizing a group of six students to accompany me to provide legal and humanitarian services to migrants at the US/Mexico border in Tijuana, Mexico in December 2018; organizing a two-day visit to campus for Justice Ruth Bader Ginsburg on the 20th anniversary of her decision mandating the admission of women to the Virginia Military Institute (VMI) in February 2017; and regularly traveling with students to Tanzania to conduct human rights work in collaboration with local partners.
