## **PARKING LOT RULES**

- Providing alcohol to anyone who is already intoxicated
- Driving under the influence of alcohol
- Canvassing or soliciting/distribution not previously authorized by the University of Colorado
- Deep fryers or any oil-based cooking or frying
- CU Boulder is a smoke free campus, this includes cigarettes, marijuana, and vapor.
- The university reserves the right to determine the appropriateness of any item or activity and to restrict vehicles due to safety reasons. At its discretion,

- Open flame fires of any kind. (Charcoal or gas cooking is permitted.)
- Weapons and fireworks
- Nitrous oxide tanks or balloons.
- Saving parking spaces
- Hiring of any third party vendors/consultants/entertainers to provide services in a parking lot without prior written authorization from the University Risk Management, Parking and Transportation Services, and Police Department.


