- III. Courtney-EBIO- Had first official safety meeting, includes mental health, want to open up committee to grad students, send an email to departments for recruitment
 - a. Joey-EBIO- Brought this issue up with John Stevenson, Kate brought it up with Cristina Gonzalez in student affairs, we will send an email out
- IV. Eldora Legislation- Kelsey Cody- ENVS
 - a. Worked on authoring the legislation with undergrad who sits on the Legislation council, potential to work with undergrad who has connections via former owner of Eldora
 - b. Sect 1&2- we view their policy as discriminatory
 - i. Section 2- UGGS invites Eldora into a dialogue with CUSG, Student Veteran Association (possible petition), student organizations
 - ii. Looking for a change in policy
 - c. Sect 3- Suggestions on policy changes
 - d. Kathryn-GEOG- Department concerns about the new policy, discriminatory not just toward graduate students but veterans and non-traditional students
 - e. John-PSYC- Is the word discriminatory/discrimination used in the letter?i. The implication was there
 - f. Will-CHEM- Are we a small population who buys the passes?
 - i. Laura-PSYC- Over half of the student passes were over 26+
 - g. Ben-PSCI- Veil is owned a majority of shareholders are the children of vets, they contribute to many causes. Perhaps we just have a petition rather than accusing them of discrimination to urge them to reconsider. There have been no vets spoken with who want to picket, but would rather sign a petition
 - h. Akshay-ITP- Can we use UGGS to send out a survey and send that info along to Eldora indicating the interest in the students who are affected
 - i. Laura-PSYC- Veil and Eldora are still separate entities, the EPIC pass is a one-time terminal agreement
 - i. Comments on the Camera article are scathing, accusing students of being privileged and it's a luxury, not a right

- ii. Cause is not being taken very seriously by the general public via these comments
- j. Will-CHEM- If fraud is the issue, we can show transcripts to curb this problem
- k. Kathryn-GEOG- The letter points to these options, that there is a benefit to having a student pass, the surveys seem like better tools
- 1. Ben-PSCI- It is rather easy to fake a transcript, perhaps a way to offer a certification that the transcript is real to reduce fraud
 - i. Transcripts may lead to interpretative difficulties, i.e.- dissertation credits
- m. Kelsey-ENVS- There are partnerships with Eldora and the UMC, potentially make them aware that the space available to them in the UMC could be eliminated
- n. Motion to endorse the letter
 - i. One objection
- o. Vote by show of hands
 - i. 17 in favor
 - ii. 2 opposed
 - iii. 11 abstaining
 - 1. Motion passes- UGGS will endorse the letter
- p. Motion to approve the legislation
 - i. Objection
 - 1. Discussion- Ben-PSCI- I think we need a plan before we ask them to engage in a dialogue
 - a. Evan-LING- in the letter they offer for the student to login to student account to show transcripts
 - b. Kelsey-ENVS- I agree we should have something specific, if the school considers you full time if you are degree seeking were two conditions we are considering
 - c. Alan-EBIO- Usually a letter from the department that specifies if you are student, an RA/TA works for the government
 - ii. Vote by show of hands
 - 1. 17 in favor
 - 2. 5 opposed
 - 3. 7 abstaining
 - a. Motion carries- pass resolution as it stands
 - iii. Laura-PSYC- We should have a follow up with more specifics
- V. Student Fees- Walker Williams-LAW, Chris S.- CSCI
 - a. Chris-CSCI- Two goals- Inform about where fees are going as well as what services are available
 - i. 14 different cost centers, programs or building that CUSG controls/governs those entities
 - ii. Rec center- one of the cost centers that the student fee for grad students vary over time

- 1. Post comps are not required to pay the student few, prior to that it is mandatory; must opt in if you want to continue using the rec center
- 2. Be-Fit pass- unlimited classes with associated costs
- 3. Swimming, Rugby, Lacrosse- Club Sports
- 4. Renovation ending in March 2014
- 5. Alan-EBIO- Bear creek is also included? a. Yes
- 6. Student fee will go up in Spring
- iii. UMC is the second largest cost center
 - 1. Student center, houses student groups, dining service
 - 2. Originally established as a center memorializing students who have served in the armed forces
 - 3. Panda Express and Cold Stone opening soon
 - 4. Events planning/catering housed here, using space on campus is scheduled in the UMC
 - 5. Connection- Bowling alley, full Hotel liquor license
 - 6. Student enrollment office, program council
 - 7. CU Night Ride funded through UMC through student government
- iv. Off-Campus Housing
 - 1. Located in the UMC 313, help students find housing offcampus
 - a. Ralphie's List- updated list of off campus housing
 - 2. Free legal services to review leases for free, advice for landlord/tenant conflicts
 - 3. Cultural Board
 - a. Bring world class speakers to address issues such as diversity and cultural relevant concerns
 - b. Kelsey-ENVS- Not enough grad students who form student groups- you get money to do things that you enjoy, funding opportunities for events
- v. GLBTQ Center- N450 of C4C
 - 1. Educating the student body about gender sensitivity
 - 2. Provides scholarships/.internships for those doing advocacy in these areas
 - 3. Potential mentorship program for grad to undergrad mentoring
- vi. Student Group Funding Board
 - 1. Student groups can receive up to 20K a year, for events, travel, and operations (website, printing services, banners, tents for events, oxygen kits, insurance, small rounds of payroll and food for events
 - 2. Starting in late Fall/Spring- Affiliated independent groups can apply for funding
- vii. Women's Health Center

- 1. BC, Family planning, free pregnancy tests, events that address gender issues, health and wellness
- viii. Cultural Volunteerism-UMC 358
 - 1. Encourages student to do service-oriented breaks rather than traditional 'spring break at the beach' trips
 - 2. Give A Days- a few hours scheduled days to help in the community
 - ix. Student Legal Services-UMC 311
 - 1. \$25 consultation fee includes a one hour follow up
 - 2. A fee incurred after comps
 - x. Courtney-EBIO- Had concern with a stalker and legal services offered to run the court case for free
 - xi. You do have to set up an appointment
- b. Student Outreach and Retention Center for Equity- focus on underrepresented students, and retaining them
- c. A few small costs centers as well
- d. Environmental Center- Works on sustainable practices on campus including lab waste reduction, water bottle filling stations, zero waste at football games
 - i. Run the recycling center across campus- over \$1MM annual funding
- e. Many of these centers have boards where grad students are encouraged to sit upon for student input
- f. Student Health Board, Student Group Funding Board, Finance Board, Environmental Center Board
- g. Ben-PSCI- Running a student group, can't spend money on food or alcohol- why?
 - i. Alcohol for the UGGS event was donated, food you can get a small portion, working on reform to enhance food and payroll- for many student groups that is how you recruit people to the meeting
- h. Ben-PSCI-Travel is a bit restrictive limiting the number of students who can travel on the groups costs
- i. Alaina-ENGL- English Language Student Council, it was not made clear to our group that 5% of our budget was for food, but there are other places where you can obtain money for food for events
- j. Ben-PSCI- It is not just recruiting, we want to have traditional cakes for events, or food for balls that are culturally relevant to the Veterans groupthe restrictions on the budget undermine these events
- k. Ben-PHIL- Several people are frustrated by the amount of money spent in student fees. What % of our student fees go to these entities
 - 1. We can send a link along with the powerpoint
 - 2. Rec center and UMC- 25% of fees
- 1. Walker-LAW-Our fees are higher because many of those services are wrapped into tuition at other comparable universities- I can offer to walk students through the fee breakdown, contact for more information

- m. Ben-PHIL- The importance for rolling the fees into tuition since many RA/TA students have this paid for
- n. Walker-LAW- We have over 400 responses on the student fee survey and are pushing for a higher turnout, please pass along
- o. Chris-CSCI- Looking for suggestions on how to enhance these cost centers, what students find are more important
- p. Evan-LING- Students express concern about the rec center costs when they do not use it
- q. Will-CHEM- Why are they upset?
 - i. Evan-LING- Particularly the Buffalo Shaped Pool
- r. Ben-PSCI- A student who is handicapped was more interested in using his fees toward making campus more accessible than toward centers that he is unable to use
- s. Danny-CLAS- Is the capital fee a permanent fixtures?
 - i. For the rec center no, there will always be building construction, but this particular one is wrapped up in student fees as they needed this to build them. As a state institute, they typically fund all the other construction
 - ii. CUSG- Community Safety Board meeting October1. Humanities 125
