- Richard ATOC Grad stud poster conf need easels; Melinda (EBIO) suggested he call
 C2B2
- Scott PSYC please send info/feedback about non-academic job training (he has had 4 so far); he will present on that next mtg
- Laura PSYC next week NAGPS conf; John, Kate, and Laura presenting on Data Driven
 Decision Making (fee timing, and talk about grad students social climate survey); let
 them know if you have anything to share on those topics...they will update us upon
 return!
- Mike Coffey ECEN ongoing RA/TA appt issue in his dept: told he was going to be instructor (RA vs TA); has not heard yet; already on a 50% RA; dept created a "practicum"; they are having a grad comm mtg and he said he would bring it up; but then said, "when I go to this mtg and advocate for you." John Stevenson helped advocate; this is important ONE grad student spoke up!! (but probably more concerns)
 - Casey supposed to be in <u>grad student rights and responsibilities</u>; there is supposed to be a grad student on the grad stu cmte for the dept – is there? need to ask that; pretty sure that is in the Bill of Rights...
 - KEEP US UPDATED!!!!

John L – Is there a CUSG election this week? Sarah A did not even know about it; there has been NO CAMPAIGNING; rules very restrictive now. Alan CHEM - turnout is already so low! There are <u>candidate bios on the website</u> Sarah A will send update to John L.

VI. Employee pay cards

- Casey ENVS and Alan CHBE: they met and asked a bunch of questions; (bkgrd CU changed and auto-enrolled them into pay cards which are *pre-paid debit cards and have fees* if you do not use them within a certain time); University saving \$50k per year; accts do not accumulate interest; called a "money account" someone is making money on these...(NOTE: they are USEFUL for international students, better than check cashing) could we negotiate a solution that meets everyone's needs? if you are auto-enrolled, you need to get out of it which takes a lot of bureaucracy; cardholder agreement; \$1.50 to get balance or use card
- CUSG is active on this issue as well...
- Casey ENVS said he would send cardholder agreement; most info can be found here.
- John L and Judon of CUSG will be going to Denver to meet with these guys will update
 us.

VII. Graduate student climate survey

- John L Now in official DRAFT 1 in Qualtrics; thank you for pre-testing! Moving towards a final draft and will keep us updated; will have a report at next meeting

- Laura PSYC remember in designing it, they wanted the survey tied to ACTIONABLE ITEMS

VIII. Campus Climate Symposium

- John L three planned for semester; already been two; third one will be driven by UGGS and CUSG: 11/14 Fri 3p (maybe social event right after to draw students!); topic is power dynamics, the hierarchy in academia; very relevant to grad students; mostly Q and A; need gen topics, situations; this week reaching out to Ombuds, Dean of Stu; getting panelists
- one thing trying to do diff is more democratic method for selecting panelists so please give feedback!
- Evan LING when will themes will be finalized when all panelists are chosen? May want to contact Prof Cowell in PHIL (he took over)
- will finalize by end of next week...

IX. UGGS Constitution

John L BKGRD - last spring we reviewed constitution and bylaws, we made some changes (all pretty minor); but one issue came up about VOTING and number of VOTES per dept 4/30 mtg proposed amendment to NOT have officers vote; reviewed edits in google doc together – here is the text in question:

SECTION 1. Voting Members

The UGGS Assembly will consist of all eligible voting members. An eligible voting member is

- any duly selected representative of any campus department, research center, or institute.
- an UGGS officer.
- The holder of any elected or appointed UGGS position an office coordinator or other
 appointed position, if they are a duly selected representative of their academic
 department, research center, or institute; however, the office coordinator may not
 vote during secret ballots.
- everything except for this was approved and this was tabled; ad hoc working group created; present info and perspective to vote in fall.
- first we need to untable it; then DISCUSS; anyone can Call to Question (end convo)
- motion untabled and seconded
- Will Ames PHYS led the working group (Erik N FRIT, Jorge JILA, Megan ATLS, Casey ENVS); it was a lot of work, over the summer and voluntary
- Will asked initially why officers had votes...
 - They did a survey of other gov groups and found POWERPOINT WILL BE LINKED HERE
 - main diffs: we are the only one that lets officers vote; only one w/o
 proportional rep, and the only ones that gives votes to non-degree granting
 institutions; and NO QUORUM RULE
 - GOALS:
 - larger depts = more votes
 - smaller depts should not be overwhelmed
 - quorum rule
 - WHY? the work we do is great, but we need to reasonably represent grad stu population; right now we do not do that
 - small depts still have adequate power; will not get outvoted
 - we give ourselves extra credibility!

QUESTIONS/DISCUSSION

- Mike LING: found three schools with voting officers...
- Laura PSYC looked at current NAGPS members and PAC12 schools; 14 total schools;
 4 out of 14 did not allow officers to vote (need to be sure they mean "office vote" the same way we do)
- Mike ECEN 15% quorum number seems really low; Will PHYS they wanted there to be set lower for "lean times" when we do not have good representation
- it would probably end up being 13 votes/10 depts
- John PSYC: FIRST WE NEED TO MAKE A DECISION TO ADOPT LANGUAGE AS IS
- we need to do that first, then move on; and the amendments can be added in the spring
- CALL TO QUESTION...
 - move to vote, officers will abstain (based on what was said at the last mtg)
 - DID NOT PASS (did not have ¾, only 57%) CLOSEST VOTE EVER (8 yay, 6 nay)
 - Kate EDUC now we can consider changes in the package for spring constitutional updates!
